<b>Implications (e.g. Financial, Statutory etc)</b>	
<p>Health and Social Care Act 2012 places a statutory requirement on Health and Wellbeing Boards to have a Joint Health and Wellbeing Strategy (by the local authority and clinical commissioning groups) that spans NHS, social care and public health priorities and the wider determinants of health, taking a key role in overseeing delivery.</p> <p>The Health and Wellbeing Board Strategy will work to encourage those who arrange the provision of health and social care services in Sandwell to work in an integrated manner and adopt a similar approach with other health-related services e.g. transport and housing where appropriate. It will also aim to adopt joint working arrangements with voluntary sector organisations and partners across Sandwell and regionally.</p>
