1. The purpose of the proposal or decision required (Please provide as much information as possible)

Agreement is sought to proceed with the development and operation (staffing etc) of an 80 bed en-suite specialist integrated Social Care and Health Centre at the "Knowle" site at Harvest Road, Rowley Regis, together with all necessary support facilities and equipment, to provide modern, effective and efficient short-term intermediate care (maximum 6 weeks' stay) for Sandwell citizens.

This proposal has previously been approved by Cabinet in December 2018, however, is required to be submitted again as Tenders for the build have come in over budget and extra monies are required to be approved in order for the project to proceed. A review of the original SIU has taken place and the extra money required has been approved by the Joint Partnership Board and the Director of Adult Social Care.

2. Evidence used/considered

Various data streams have been used to formulate the report, with particular regard to projecting the future need and demand for bed-based intermediate care, and the best service model for that care and support. For example, the latest Sandwell demographic information, population projections and lifestyle data from the Office of National Statistics and the General Household Survey, Adult Social Care and Public Health Outcomes Framework comparative data, Sandwell Better Care Fund Performance Dashboard, the Sandwell and West Birmingham NHS Trust full business case for the proposed Midland Metropolitan Hospital, and the latest national Intermediate Care Survey report.

3. Consultation

The report has been consulted on across the Council and the Sandwell and West Birmingham Clinical Commissioning Group, and the Centre project, as part of the Sandwell Better Care Fund, is accountable to the Sandwell Health and Wellbeing Board.



4. Assess likely impact

Care and support from the Centre will help prevent Sandwell residents having to go into hospital and where that is unavoidable, support them to be discharged quickly and properly from Sandwell, City, Rowley, and Russell's Hall and other out of borough hospitals.

Key priorities for the Centre will be to:-

- Prevent Sandwell older people having to be admitted to hospital.
- Reduce, and maintain this, the number of people delayed unnecessarily in hospital.
- Comply with the expectations of the Care Quality Commission (CQC) and satisfy national minimum standards, building regulations, etc.
- Enable people to live as independently as possible.

The Centre's services will be for mainly older people, although with exceptions for certain younger adults who may benefit from these services – for example, people suffering from multiple sclerosis, motor neurone disease, or in need of post-stroke support.

The following benefits will be sought for Sandwell citizens:-

• Improved health, well-being and confidence, helping them to live longer with a good quality of life, and being able to contribute more to local community life.

- Maintaining their independence at home.
- Avoidance of unnecessary admission to hospital.

• Avoidance of preventable or premature admission to long term residential or nursing home care.

• Maximising potential by working to maintain skills and rehabilitation.

• Support for the transition from hospital to home.

There will also be benefits to the wider community from the Centre:-

- Opportunities to offer construction training places leading potentially to offers of full time employment.
- Opportunities for the main and sub-contractors to recruit local labour.
- Benefits to local economies through Think Sandwell and the use of local supply chains.



- Links to project work with local schools, both in terms of syllabus and more general activities.
- Community cohesion.
- The redevelopment of a vacant site which may have blighted the local area and the impact of the project in terms of creating sustainable neighbourhoods.
- Community hub and access to well-being activities and initiatives.
- Equipment "sub" store for assessment of needs and provision of aids to daily living for local community.

Age	•			 As stated above, the Centre's services will be for mainly older people (65+), although with exceptions for certain younger adults who may benefit from these services – for example, people suffering from multiple sclerosis, motor neurone disease, or in need of post-stroke support. The national and local evidence clearly points to the fact that the vast proportion of people who are currently admitted to hospital who do not need to be admitted, or who are delayed unnecessarily waiting for an assessment and/or a more appropriate alternative form of care, are older adults. All people admitted to the Centre will do so via a full and proper multiagency assessment of the citizens' needs through the Sandwell Integrated Hub, continuous re-assessment will feature prominently



	throughout the citizen's stay at the Centre and their discharge and the moving-on process.
Disability 🗸	The Centre will be designed and equipped to meet the latest building regulations, and in particular those relating to accessibility to residential properties and that would help to overcome problems for people with mobility issues. Indeed, it is likely that a significant proportion of people admitted to the Centre will need short-term assistance/rehabilitation/reablement literally to help them "get back on their feet".The Centre will also need to meet Care Quality Commission fundamental standards.Specific design and facilities' provision will be made for people in wheelchairs and for those people with bariatric requirements i.e over 25 stones in weight.

The development and mobilisation of the Centre will be monitored through site meetings and the Centre Development Steering Group. In turn, through the BCF Project Manager and the Divisional Manager Prevention and Integration, the Steering Group will report and be accountable to the Joint Partnership Board and then Sandwell Health and Wellbeing Board (as all of the annual costs and a large proportion of the capital cost will be funded from the Better Care Fund.

On completion and mobilisation of the Centre, admission to and discharges from the Centre, and monitoring of the performance of its services and the usage of the building and its facilities, will be overseen and directed by the Integrated Hub and the BCF Programme. This will examine, amongst other things, issues such as age profile, ethnicity and longer-term care and accommodation needs.
