# 1. The purpose of the proposal or decision required

Genito-Urinary Medicine (GUM) and CaSH services are open access services. This means Sandwell patients can choose to attend services in any part of the country, the cost of which will be met by Public Health budget of Sandwell MBC. University Hospitals Birmingham NHS Foundation Trust (UHB) is Sandwell's second largest provider of these services. On 21 January 2015 Cabinet gave approval for "Genito-Urinary Medicine (GUM) and Contraceptive and Sexual Health (CaSH) Direct Contract Award for the period 1 April 2015 to 31 March 2017, with an option to extend for up to two years with University Hospitals Birmingham NHS Foundation Trust (UHB). Following this decision the council currently pays UBH an advance block grant for CaSH attendances. UHB invoices the council for GUM attendances on a quarterly basis.

The council was unable to enter into contract but was still required to pay for the GUM and CaSH services delivered due to patient choice and to remain compliant with national guidelines. Additionally, entering into a contract with UHB is not currently permissible under the terms of the council's Cooperative Working Agreement covering sexual health services with Sandwell and West Birmingham Hospitals.

An exemption was sought and granted approving exemption from rule 20.8 of the council's Procurement and Contract Procedure Rules, to allow payment to University Hospital Birmingham NHS Foundation Trust (UHB) for delivered Genito-Urinary Medicine (GUM) and Contraceptive and Sexual Health (CaSH) services without a contract. The council currently pays UBH an advance block grant for CaSH attendances. UHB invoices the council for GUM attendances on a quarterly basis.

Analysis of the attendance numbers by Sandwell residents at UHB clinics for CaSH in the current financial year demonstrates that the current CaSH block payment agreed with UHB is too high. Additionally, changes in the way residents are accessing sexual health services due to the pandemic indicate that the number of residents going out-of-area to access UHB CaSH services is likely to decline, creating uncertainty about the appropriate value of future payments to UHB.
