


# Approval For Safer Streets Funding of £331,250 if SMBC Bid Successful



### January 2021 Home Office Launch Safer Streets Fund

• £20m available to bidders, working in partnership to design and deliver local crime prevention plans in hotspot areas to reducing neighbourhood crimes through situational prevention.



#### **Fund Objectives:**

- Reduce neighbourhood crime (burglary, vehicle related theft, theft from the person, robbery) making local areas safer and reducing demand on the police to focus on higher harm crimes.
- Build evidence about the impact of targeted investment in situational prevention to strengthen case for future investment.
- Grow local capability to undertake data driven problem solving and capture evidence and practical learning about how best to implement situational interventions to prevent crime.

## **Criteria for Bids**

- that areas have a defined, but not necessarily adjoined geography,
- that the intervention area is a suitable size to enable effective targeting, 500 to 3,500 households (or 1,000 to 9,000 residents),
- that the areas are persistently and disproportionately affected by one or more neighbourhood crime types.
- focus on Lower Super Output Areas
- targeted focus on four neighbourhood crime types; domestic burglary; vehicle theft (theft of and from vehicles); theft from the person and robbery which meet the required benchmarks

Crime Type	Benchmark crime rate using police.uk data (crimes per 1000 population per year)
All Neighbourhood Crime ( Burglary, Robbery, Theft from Person & Vehicle Crime)	18.30
Vehicle Crime	8.74
Burglary	7.91
Robbery	1.16

 February 2021, Following Initial Expression of Interest, Sandwell selected as 1 of 3 local areas to bid by Police & Crime Commissioner






## Areas Selected – Abbey & West Bromwich Central





## Abbey & West Bromwich Central

 Both areas have high levels of income deprivation, unemployment, long term unemployment, child poverty, older people living alone and older people deprivation. (Source Sandwell Trends). All of which have been intensified by Covid and both are persistently and disproportionately affected by one or more neighbourhood crime types well exceeding the benchmarking criteria.



#### **Achievements & Outcomes**

- Working with businesses encouraging repair and maintenance. Instilling a pride in their area.
- Guiding and encouraging the use of main frontage access routes where there is maximum natural surveillance. Reduce access to concealed vulnerable rear areas
- Working with victims of residential crime encouraging management and maintenance.
- Scoping for voluntary organisations with limited additional funds where necessary to add gating, window locks, property marking.
- Garden maintenance if necessary particularly the older and vulnerable victims.
- Installation of additional CCTV linked to SMBC Control Room
