The Board discussed its work programme for the 2015/16 municipal year. Members were informed about a number of housing related policies and strategies that are due for review during the year and agreed an approach to carry out scrutiny of these with groups of councillors conducting research and carrying out evidence gathering visits.

The Board agreed the following key areas for scrutiny:

- Allocations Policy;
- Housing Strategy;
- Adaptations Policy.

Members volunteered to work on the various areas and it was agreed that information packs would be prepared to provide a starting point for building understanding of the topics.

It was reported that there is also an on-going multi-agency working group conducting a review of Tenant Involvement in Sandwell. The Chair and Vice-Chair of the Scrutiny Board are members of this group which also includes officers and tenants. The findings and recommendations for improvement arising from the working group will be reported to the Board in due course for consideration. The Board also discussed a number of other topics that it wished to receive reports on throughout the year.
