4. Legal and Statutory Implications

- 4.2 If insurance is not available then the take up of the appointment to the organisation is at the Councillor's own risk.

5. Implications for the Council's Scorecard Priorities

The involvement of Council appointed representatives in the decision making process of other bodies, at local, regional and national levels, might encourage better understanding of local and wider needs and viewpoints and will help support the priorities as set out in the Council's Scorecard.

6. Background Details

Mackmillan Educational Foundation

The Mackmillan Educational Foundation promotes the education of persons under 25 years old from the Rowley Regis area of Sandwell through financial assistance to individuals.

Appointments are for a period of four years and may be, but need not be, a Councillor. The Council's other representatives on the Foundation are Councillor Webb and Mr Hamblett (expiring 2016), Councillors Eaves and Shackleton (expiring 2017) and Councillors Carmichael and B Price (expiring 2019). The Council is now asked to appoint one additional representative.

Rowley Regis Consolidated Charities

The Rowley Regis Consolidated Charities aims to relieve hardship generally and for individuals in the wards of Blackheath, Cradley Heath and Old Hill, Rowley Regis and Tividale.

Appointments are for a period of four years and may be, but need not be, a Councillor. The Council's other representatives on the body are Councillors Ashman, B Price, Shackleton and Tranter. The Council is now asked to appoint one additional representative.
