

S C H E M E.

1. Administration of Charities. - (1) The above-mentioned Charities and the property thereof specified in the schedule hereto and all other the property (if any) of the Charities shall be administered and managed subject to and in conformity with the provisions of this Scheme.

(2) The Charities numbered 1 and 2 above shall be administered and managed together as one Charity under the title of The Harborne Parish Lands Charity (hereinafter referred to as the Parish Lands Charity).

(3) The Parish Lands Charity and the Charity numbered 3 above shall be administered and managed by a body of Trustees hereinafter constituted, and are hereinafter referred to as the Charities.

2. Investment of cash. - Sums of cash at any time belonging to the Charities and not needed for immediate working purposes shall be invested in the name of the Official Custodian for Charities unless the Charity Commissioners otherwise direct.

3. Meaning of expression. - In this Scheme, the expression "area of benefit" shall mean the area of the Ecclesiastical Parishes of St. Boniface Quinton Road West Birmingham, St. Faith and St. Laurence, Harborne, St. Harborne, St. Peter, Harborne, St. Albans, Smethwick, St. Chad, Smethwick, St. Mary, Smethwick, St. Matthew, Smethwick, St. Michael and All Angels, Smethwick, St. Stephens, Smethwick and St. Paul, West Smethwick.
