# **DECISION RECOMMENDATIONS**

- (1) that the office of Honorary Freeman of the Borough be conferred upon Mr David Manners;
- (2) that the Director Monitoring Officer, in consultation with the Mayor and Leader of the Council, be authorised to make the appropriate arrangements to implement the decision set out in (1) above.

### 1 PURPOSE OF THE REPORT

- 1.1 The General Purposes and Arbitration Committee, at its meeting held on 20 August 2018, considered proposals to admit suitable persons as Honorary Freeman of the Borough.
- 1.2 All members of the General Purposes and Arbitration Committee supported a proposal from Councillor Gavan that the following person be nominated for their exceptional achievements and outstanding support and service to the Council and to the Borough:

#### **Mr David Manners**

Mr Manners was born and raised in Smethwick and has been an exemplary employer for over 40 years. In addition, he has donated significant amounts of money to local charities over the years, and continues to do so. Mr Manners also undertakes a great deal of unsponsored work for the local community.

Mr Manners has demonstrated exceptional innovation and entrepreneurship, which is delivering significant economic growth and prosperity in the borough of Sandwell. Mr Manners has exemplified selflessness and sustained commitment to the community through charitable deeds.

1.3 The Committee resolved to recommend to the Council that the office of Honorary Freeman of the Borough be conferred upon Mr David Manners.
