Reason for Urgency/Special	On 25th September 2020 the Department of
Urgency:	Health and Social Care introduced Test and Trace Support Payments and Discretionary Support Payments for people who are required to self-isolate because they have either tested positive for COVID-19 or have been identified by NHS Test and Trace as a close contact. They want Local Authorities to commence making payments from 12th October 2020. In order to achieve this our discretionary policy needs to be in place.

DECISION RECOMMENDATIONS

That the Emergency Committee:

1. Approves the attached Discretionary Test and Trace Support Payment Scheme Policy.

1 REASONS FOR THE RECOMMENDATIONS

- 1.1 During September, in response to Covid-19, the Department for Health and Social Care introduced Test and Trace support payments. These are aimed at helping people who have been financially affected because they are unable to work following an instruction to self-isolate because they have either tested positive for Covid-19 or have been identified by NHS Test and Trace as a close contact.
- 1.2 Revised guidance on the Discretionary Test and Trace support payments was received from Department of Health and Social Care on 30th September 2020 and details of funding on 2nd October 2020. The guidance details qualifying criteria for the discretionary scheme and stipulates that the council must publish their scheme.
- 1.3 This report seeks approval of the Discretionary Test and Trace Support Payment Scheme Policy which is included in Appendix 1.

3 PURPOSE OF THE REPORT

3.1 To approve Sandwell's Discretionary Test and Trace Support payment scheme Policy (appendix 1).

4 IMPLICATION FOR VISION 2030

- 4.1 Payment of these discretionary payments will provide crucial financial support to people who have suffered losses in income because of the pandemic.
- 4.2 Helping people survive the pandemic links directly to Ambition 10.

5 BACKGROUND AND MAIN CONSIDERATIONS

- 5.1 The Test and Trace support payments were formally launched by the Department of Health and Social Care on 25th September 2020.
- 5.2 To receive the main (non discretionary) Test & Trace Support Payment of £500, you must:

- have been asked to self-isolate by NHS Test & Trace either because you've tested positive for coronavirus or have recently been in close contact with someone who has tested positive
- be employed or self-employed
- be unable to work from home and will lose income as a result
- be currently receiving Universal Credit, Working Tax Credit, incomebased Employment & Support Allowance, income-based Jobseeker's Allowance, Income Support, Housing Benefit and/or Pension Credit.
- 5.3 To be considered for the Test and Trace Discretionary Support Payment Scheme of £500 a person must:
 - have been asked to self-isolate by NHS Test & Trace on or after 28th September 2020 either because they have tested positive for coronavirus or have recently been in close contact with someone who has tested positive
 - be employed or self-employed
 - be unable to work from home and will lose income as a result
 - be on a low income
 - be suffering financial hardship.
- 5.4 The Department of Health and Social Care have prescribed the above criteria to Local Authorities. They have advised that the Test and Trace Support Scheme should be available to make applications from 12th October 2020 and support payments should be made within 3 days from the receipt of applications. The scheme will run until the 31st January 2021.
- 5.5 Sandwell have received funding of £189k for the main Test and Trace Support Scheme and £113k for the Discretionary scheme.
- 5.6 The Department of Health and Social Care launched the Test and Trace Support Payment Scheme and Discretionary Scheme in September and this report is seeking approval of Sandwell's Discretionary Test and Trace Support Payment Scheme Policy (appendix 1).

6 THE CURRENT POSITION

- 6.1 Since the Test and Trace Support Payment Scheme was announced in September 2020, Revenues and Benefits have been working on the procedures and application form to accompany its implementation.
- 6.2 We are currently waiting for localised access to the Contract Tracing Service to enable staff to verify the NHS contract and trace reference number and the period of isolation.

6.3 The scheme is due to go live in Sandwell on the 12th October 2020.

8.3 The Department of Health and Social Care have provided funding for Test and Trace Support Schemes. New burdens funding will also be provided to cover the cost of administration.

9.3 The Department of Health and Social Care requires councils to publish their Discretionary Test and Trace Support Payment Scheme. Once the scheme is approved it will be published on www.sandwell.gov.uk.
