#### 1/14 **Minutes**

**Resolved** that the minutes of the meeting held on 6<sup>th</sup> September, 2013, be confirmed as a correct record.

### 2/14 Review of Fees and Charges under the Gambling Act 2005

The Committee considered a report detailing proposed charges for services for 2014/15 in relation to premises licences and other permissions under the Gambling Act 2005.

Members noted that the Council required all divisions to undertake a review of its fees and charges on an annual basis.

The Committee was advised that some of the fees were set by statute and so it was not possible to alter these charges. However, where it was possible to alter charges, a 2% uplift had been applied.

**Resolved:** that the fees and charges for 2014/15 for Premises Licences and permissions under the Gambling Act 2005, as set out in the Appendix, be approved, with effect from 1<sup>st</sup> April, 2013.

# 3/14 <u>The Licensing Act 2003 – Review of Statement of Licensing</u> Policy

Further to Minute No.10/13, the Committee considered the review of Statement of Licensing Policy which sets out how the authority intended to carry out its licensing functions under the Act.

Section 5 of the Licensing Act 2003 (the Act) required the Council as the Licensing Authority to prepare and publish its own Statement of Licensing Policy and the current Statement had been approved by full Council and became effective from 7<sup>th</sup> January, 2011.

The Act required the Council, in respect of each five year period, to determine its policy with respect to the exercise of its licensing functions, and publish a statement of that policy before the beginning of the period.

The next five year period was not due to commence until January 2016, but there had been a number of legislative changes to the licensing process so it was considered more appropriate to review the policy now.

At its meeting on 6<sup>th</sup> September, 2013 the Committee gave approval to a formal consultation exercise between September and November 2013.

The only comments received as part of the consultation process were from the Town Service Improvement Boards for Tipton, Wednesbury, Rowley Regis and Oldbury and the Committee gave consideration to the Comments made.

The Committee identified a need for the Clinical Commission Group to be included in any future consultation on the licensing policy.

A report would be submitted to the full Council meeting in March, 2014 for the Licensing Policy to be approved.

**Resolved** that the revised Statement of Licensing Policy, be recommended to the Council for approval.
