1/19 Minutes

Resolved that the minutes of the meeting of the Licensing Committee, held on 13th November 2018, be confirmed as a correct record.

2/19 Revision to Appointments to Licensing Sub Committees

Approval was sought to revise membership of the three Sub Committees as set out in Appendix 1.

At its meeting on 13th November 2018 the Licensing Committee approved revised appointments to Sub Committees, pending the appointment of a second Vice Chair.

Further to Minute No. 8/18 (Licensing Committee, 13th November 2018), a second Vice Chair was appointed to the Licensing Committee by Council, at its meeting on 15th January 2019 (Minute No. 9/19 referred), and approval was sought to the revised appointment to Sub Committees for the remainder of the municipal year.

Resolved that the revised membership of the three Sub Committees, as set out in Appendix 1, be approved for the remainder of the municipal year.

3/19 Review of Fees and Charges under the Licensing Act 2003 and Gambling Act 2005

At its meeting on 31st January 2018, the Cabinet recommended that the Licensing Committee approve the fees and charges in relation to premises licences and other permissions under the Licensing Act 2003 and the Gambling Act 2005, as set out in Appendix 2, with effect from 1st April 2018.

The report set out the proposed fees and charges for the period 2019/20 in relation to premises licences and other permissions under the Licensing Act 2003 and the Gambling Act 2005.

The Council's policies under both the Licensing Act 2003 and Gambling Act 2005 were subject to regular review and consultation with the widest possible range of stakeholders. The list of stakeholders was subject to agreement with the Licensing Committee. The Council's Gambling Policy 2005 Statement of Principles was approved by Council on 20th October 2015 and implemented on 31st January 2016.

An initial equality impact assessment had been carried out and no issues had been identified that impacted on a particular group and therefore a full assessment was not required.

A review of the current fees was underway, and a further report would be submitted to Committee at a future meeting.

Resolved that the fees and charges for 2019/20 for premises licences and permissions under the Licensing Act 2003 and the Gambling Act 2005, as set out in Appendix 2, be approved with effect from 1st April 2019.

Establishment of Licensing Sub Committees

1. Summary Statement

- 1.1 At its annual meeting on 21 May 2019, the Council appointed a statutory Licensing Committee which the Council also declared would also sit as the Council Committee to carry out other licensing functions.
- 1.2 Under the provisions of the Licensing Act 2003, the Licensing Committee may establish one or more Licensing Sub Committees to assist in the discharge of the licensing functions under the Licensing Act, 2003. Further such functions of the Gambling Act, 2005 may also be discharged by those Sub Committees.
- 1.3 The Committee is invited to establish Licensing Sub Committees for the municipal year 2019/2020.
- 1.4 The Licensing Act 2003 specifies that each Sub Committee shall consist of three members of the Licensing Committee. The Council at its meeting on 21 May 2019 appointed a Licensing Committee comprising 15 members, including one Chair and two Vice Chairs.
- 1.5 It is proposed that three Sub Committees, consisting of five/six members, with a Chair/Vice Chair each sitting on a Sub Committee, be appointed for 2019/20. However, in accordance with the provisions of the Act, Sub Committees sitting to consider Licensing Act 2003/Gambling Act 2005 functions must consist of only three members.
- 1.6 It is recommended that the Director of Law and Governance and Monitoring Officer, in consultation with the Chair of the Licensing Committee, be authorised to select members from the Licensing Committee to serve on Sub Committees as necessary and to ensure a quorum should a named member not be available for a meeting or unable to consider a particular case due to a conflict of interest.
- 1.7 Approval is also sought to the terms of reference for the Sub Committees, as set out in Appendix 1.

Further details are attached for your information.

2. Recommendations

- 2.1 That the Terms of Reference for the Licensing Sub Committees, as set out in Appendix 1, be approved.
- 2.2 That three Sub Committees be established, to undertake those functions set out in the terms of reference referred to in 2.1 above, each comprising three members of the Licensing Committee when considering matters in relation to the Licensing Act 2003/Gambling Act 2005 and five/six members of the Licensing Committee when considering matters affecting applications for licences and licences previously granted under the terms of the Local Government (Miscellaneous Provisions) Act 1976, and that the Committee make appointments to those Sub Committees.
- 2.3 That the Director of Law and Governance and Monitoring Officer, in consultation with the Chair of the Licensing Committee, be authorised to select members from the Licensing Committee as necessary to serve on Licensing Sub Committees to ensure a quorum should a named member not be available for a meeting or unable to consider a particular case due to a conflict of interest.
- 2.4 That the Head of Governance be authorised to make the necessary changes to the Council's Constitution in order to reflect the decisions of the Committee on the above recommendations.

3. Strategic Resource Implications

The costs arising from the administration and servicing of the Licensing Sub Committees will be met from existing budgets.

4. Legal and Statutory Implications

- 4.1 In order for the same members to make all licensing decisions, the Council may appoint a statutory licensing committee and then declare that that committee may also sit as a Council committee to carry out other licensing functions.
- 4.2 Section 3 of the Licensing Act 2003 provides that the Council is a Licensing Authority and as such the Council must carry out its functions under the Licensing Act, 2003.
- 4.3 Under Section 6 of the Licensing Act, 2003 each Licensing Authority must establish a licensing committee consisting of at least ten, but not more than fifteen, members of the authority.
- 4.4 Section 9 of the Licensing Act, 2003 states that a licensing committee may establish one or more sub-committees consisting of three members of the committee, and Section 10 provides that the committee may arrange for the discharge of any functions exercisable by it by a sub-committee established by it, or an officer of the licensing authority.
- 4.5 Section 2 of the Gambling Act 2005 further states that the Council is a licensing authority. The Gambling Act 2005 places a duty on the Council to undertake the licensing functions specified in the Act.
- 4.6 Section 154 of the Gambling Act 2005 provides that all decisions, subject to exceptions, relating to premises licences are delegated to the licensing committee of the authority that has been established under Section 6 of the Licensing Act, 2003.
- 4.7 Section 154(3) of the Gambling Act, 2005 states that Section 10 of the Licensing Act 2003 shall apply in relation to a function delegated to a licensing committee as they apply in relation to a function delegated under that Act.
- 4.8 The 2003 Act and the 2005 Act allow the Licensing Committee to arrange for the discharge of any of its functions by a Sub-Committee or by an Officer of the Licensing Authority. Arrangements may provide for more than one sub-committee or officer to discharge the same functions concurrently.
- 4.9 Article 6 of the Human Rights Act 1998 state that in determination of a persons civil rights and obligations, everyone is entitled to a fair and public hearing within a reasonable time by an independent and impartial tribunal established by law.

- 4.10 Article 8 states that everyone has the right to respect for his private and family life, his home and his correspondence.
- 4.11 Part II, Article 1 of the Act states that every natural or legal person is entitled to the peaceful enjoyment of his possessions. No one shall be deprived of his possessions except in the public interest and subject to the conditions provided for by law and by the general principles on international law.
- 4.12 The Licensing Committee will review the membership of the Sub Committees each year following the appointment of members to the Licensing Committee at the Annual Council meeting.
- 4.13 Parliament has given the Council various licensing functions but legislation does not always allow choice in how a Council may operate those functions, for example, Scrap Metal Dealers licensing regime is a matter for the Leader and Cabinet to operate and the Licensing Act 2003 requires the Council to establish a statutory licensing committee to undertake licensing functions, as set out in the Act. Otherwise, the Council has general discretion to create Council committees under the Local Government Act 1972 to make licensing related decisions.

5. Implications for Sandwell's Vision 2030

- 5.1 The Licensing process contributes to the Sandwell's Vision 2030 Ambition 3 our workforce and young people are skilled and talented geared up to respond to changing business needs to win rewarding jobs in a growing economy locally.
- 5.2 The Licensing Act 2003 has four licensing objectives which are highly pertinent to Ambition 5 of Sandwell's Vision 2030 these being:-
 - (a) the prevention of crime and disorder;
 - (b) public safety;
 - (c) the prevention of public nuisance;
 - (d) the protection of children from harm.
- 5.3 Similarly, the Gambling Act 2005 has three licensing objectives, as follows:-
 - (a) Preventing gambling from being a source of crime or disorder, being associated with crime or disorder or being used to support crime;
 - (b) Ensuring that gambling is conducted in a fair and open way;
 - (c) Protecting children and other vulnerable persons from being harmed or exploited by gambling.
- 5.4 Trading Standards and Licensing is a member of the Sandwell Drug and Alcohol Policy group, which reports to the Safer Sandwell Partnership.

6. **Background Details**

The Licensing Sub Committees are appointed under the provisions of the Licensing Act, 2003 and are therefore not subject to the proportionality requirements of the Local Government and Housing Act 1989. However, other licensing functions will be subject to proportionality.

For 2019/20, the proportionality provisions will apply, when considering licensing functions other than those under the provisions of the Licensing Act 2003, and seats have been allocated to the Sub Committees accordingly.

8.2 The Licensing Act, 2003:-

Section 3 provides that the Council is a Licensing Authority and as such the Council must carry out its functions under the Licensing Act 2003.

Under Section 6 each Licensing Authority must establish a licensing committee consisting of at least ten, but not more than fifteen, members of the authority.

Section 9 states that a licensing committee may establish one or more sub-committee consisting of three members of the committee and Section 10 provides that the committee may arrange for the discharge of any functions exercisable by it by a sub-committee established by it or an officer of the licensing authority.

8.3 The Gambling Act, 2005:-

Section 2 further states that the Council is a licensing authority. The Gambling Act 2005 places a duty on the Council to undertake the licensing function specified in the Act.

Section 154 provides that all decisions subject to exceptions, relating to premises licences are delegated to the licensing committee of the authority that has been established under Section 6 of the Licensing Act 2003.

Section 154 (3) states that Section 10 of the Licensing Act, 2003 shall apply in relation to a function delegated to a licensing committee as they apply in relation to a function delegated under that Act.

8.4 Private Hire & Hackney Carriage Licensing

Section 51 of the Local Government (Miscellaneous Provisions) Act 1976 states:-

(1) Subject to the provisions of this Part of this Act, a district council shall, on the receipt of an application from any person for the grant to that person of a licence to drive private hire vehicles, grant to that person a driver's licence:

Provided that a district council shall not grant a licence—

- (a) unless they are satisfied that the applicant is a fit and proper person to hold a driver's licence; or
- (b) to any person who has not for at least twelve months been authorised to drive a motor car, or is not at the date of the application for a driver's licence so authorised.
- (2) A district council may attach to the grant of a licence under this section such conditions as they may consider reasonably necessary.

Section 57 of the Local Government (Miscellaneous Provisions) Act 1976 states:-

- (1) A district council may require any applicant for a licence under the Act of 1847 or under this Part of this Act to submit to them such information as they may reasonably consider necessary to enable them to determine whether the licence should be granted and whether conditions should be attached to any such licence.
- (2) Without prejudice to the generality of the foregoing subsection—
 - (a) a district council may require an applicant for a driver's licence in respect of a hackney carriage or a private hire vehicle—
 - (i) to produce a certificate signed by a registered medical practitioner to the effect that he is physically fit to be the driver of a hackney carriage or a private hire vehicle; and
 - (ii) whether or not such a certificate has been produced, to submit to examination by a registered medical practitioner selected by the district council as to his physical fitness to be the driver of a hackney carriage or a private hire vehicle;
- (3) if any person knowingly or recklessly makes a false statement or omits any material particular in giving information under this section, he shall be guilty of an offence.

Section 59 of the Local Government (Miscellaneous Provisions) Act 1976 states:-

- (1) Notwithstanding anything in the Act of 1847, a district council shall not grant a licence to drive a hackney carriage—
 - (a) unless they are satisfied that the applicant is a fit and proper person to hold a driver's licence; or
 - (b) to any person who has not for at least twelve months been authorised to drive a motor car, or is not at the date of the application for a driver's licence so authorised.

Section 61 of the Local Government (Miscellaneous Provisions) Act 1976 states:-

- (1) Notwithstanding anything in the Act of 1847 or in this Part of this Act, a district council may suspend or revoke or (on application therefor under section 46 of the Act of 1847 or section 51 of this Act, as the case may be) refuse to renew the licence of a driver of a hackney carriage or a private hire vehicle on any of the following grounds:—
 - (a) that he has since the grant of the licence—
 - (i) been convicted of an offence involving dishonesty, indecency or violence; or
 - (ii) been convicted of an offence under or has failed to comply with the provisions of the Act of 1847 or of this Part of this Act; or
 - (b) any other reasonable cause.
- 8.5 The 2003 Act and the 2005 Act allow the Licensing Committee to arrange for the discharge of any of its functions by a Sub Committee or by an Officer of the Licensing Authority. Arrangements may provide for more than one Sub Committee or Officer to discharge the same functions concurrently.
- 8.6 The Licensing Committee has already delegated the majority of its licensing functions to the Sub Committee and/or Officers.
- 8.7 The Licensing Committee reviews the membership of the Sub Committee each year following the appointment of members to the Licensing Committee at the Annual Council Meeting.

Foreword - Chair of the Licensing Committee

The 2018/19 municipal year was the second full year of operating the Licensing Committee under its current structure.

The Licensing Committee is made up of 15 elected members including myself as Chair and two Vice Chairs. Under the provisions of the Licensing Act 2003, the main committee is supported by three sub committees to assist in the discharge of the licensing functions.

Three members of the Licensing Committee sit when considering matters in relation to the Licensing Act 2003 and Gambling Act 2005 and five members of the Licensing Committee when considering matters affecting applications for licenses and licenses previously granted under the terms of the Local Government (Miscellaneous Provisions) Act 1976.

The Committee has considered 141 individual matters relating to the grant or review of licenses within the local authority's administrative remit. All matters are considered against the licensing regimes primary function, which is to protect the public.

In order to maintain the integrity of the service, it is essential that members of the public can feel confident and safe when engaging with licensed services throughout the borough. I would like to take this opportunity to thank fellow committee members and officers of the council involved in the licensing process for their work throughout the year and I look forward to the coming year and the challenges it presents in regulating licensable activity within Sandwell.

Temporary Event Notices permit licensable activities on unlicensed premises, or outside the hours of an existing licence, for short periods of time and are subject to restrictions on the number that can be given for premises or to an individual during a specified period.

A notice given more than ten working days before the event is a standard notice, when given between nine and five working days before the event it is a late notice.

Annual Report of the Licensing Committee 2018/19

Only the Police or Environmental Health may object. Objections to a standard notice may result in a hearing, for a late notice a counter notice is given and the event cannot go ahead.

The limit on the number of temporary events that can be held at a premise increased from 12 to 15 per year with effect from 1 January 2016.

During the course of this year there were 170 such notices (37 of these being late notices). 2 Counter notices were issued.

The work of Licensing Committee enforces key council policies and provides and effective response to local issues as they arise.

6. Enforcement Activity

Private Hire and Hackney Carriage Licensing:

Between 1 April 2018 and 31 March 2019, the Taxi Licensing Enforcement Team conducted 12 multi-agency safety operations together with officers from the Driver & Vehicle Standards Agency (DVSA), West Midlands Police, and Her Majesty's Revenue & Customs (HMRC) Fuel testers at locations across the borough.

On average 20 vehicles were checked on each operation. Findings have been that approximately 70% due to VOSA failure for mostly minor issues such as defective light bulbs which are rectified on site by the vehicle examiners so that the drivers may continue to work. Fixed Penalties continue to be issued for defective tyres and are followed up by an appearance at the Licensing Sub Committee.

General Licensing:

The Licensing Team are committed to ensure that businesses operate legally and responsibly so that our residents live in safe neighbourhoods and have a good quality of life. Whilst following the Black Country Local Authorities Enforcement Policy against those who fail to comply.

Since January 2018 the team has visited numerous licensed premises carrying out general enforcement visits and following up on complaints received. The team have been working closely with the Police and visiting 'problem' premises to ensure licence holders are complying with the operating schedule and conditions of licence.

7. Conclusion

The Committee carries out its role with a view to ensuring the public are kept safe from harm. In making its decisions, the Committee puts this perspective at the forefront of its decision making. This should provide further assurance to the public that the Council views the safety of its citizens as paramount in carrying out this function.

Members and officers are constantly reviewing Council Policy and delegations to reduce committee time and further improve the level of service offered to license holders. During the course of the next municipal year the following activities are planned:

- Completion of the review of the Alcohol Licensing Policy
- Review of the Gambling Policy
- The introduction of policies governing the licensing of scrap metal dealers and Sexual Entertainment Venues

Over the course of the 2018/19 municipal year there has been a move towards increasing the amount of operational activity that takes place online, with further work to continue in 2019/20. This will continue to both benefit the customer, by improving the efficiency and accessibility of service, and the committee, as it will increase the visibility of the work being carried out to all elected members and residents of the borough.
