## Minutes of the Select Committee for Electoral Participation

### 5/18 Minutes

**Resolved** that the minutes of the meeting held on 13<sup>th</sup> July 2018 be confirmed as a correct record.

## 6/18 **Progress Briefing and Update from Officers**

Members received a report in respect of the actions that had been agreed at the first meeting of the Electoral Participation Select Committee to assist and drive the review of Electoral Registration activity and support the work of the Committee.

Members felt that a special effort should be made to engage with particular groups within the community and progress on this was recorded in the report as follows:

- current initiatives were in place for individuals undertaking citizenship and data was supplied to produce invitations to register;
- Council Tax mailings were already utilised and included leaflets to encourage registration;
- access to data sets that were available in respect of young people leaving care and adults with learning disabilities was being explored and a detailed analysis would be provided at the conclusion of the canvass;

- levels of Service Voter Registration had been examined and currently there were 52 electors registered as service voters. A contact had been identified through the British Legion and discussion was ongoing regarding literature that could be distributed to those currently in the armed forces to promote registration:
- the elections team was currently producing a Customer Engagement Matrix which demonstrated customer contact with the Council and the variations in the way they contacted the Council. This would identify reference to electoral registration.

It had been agreed with neighbourhoods that the elections team would be provided a list of all new tenants on a monthly basis. Officers would be co-ordinating a meeting with all Town Leads to ensure a consistent approach and review the requirements for each Town area so strategies could be targeted appropriately. The Electoral Services Manager was currently working on a Data Sharing agreement across all council departments. Other initiatives that had been identified included:

- training outreach officers that were visiting properties to promote registration;
- Neighbourhood officers promoting registration at the Safer Six community events;
- all town leads to be responsible for ensuring that, where there was any customer contact, Electoral Registration was promoted

   this was especially important during the canvass period with regard to the Household Enquiry Form (HEF).

Members had been provided with a table that illustrated the decrease in the electorate in March 2018 and the new registrations received between March and September 2018.

During the canvass, households were issued with the Household Enquiry Form (HEF), any household that did not respond was then targeted by a personal visit from a canvasser, a follow up letter would then be sent and the household given fourteen days to respond, followed by a further letter notifying removal from the register.

The table demonstrated a 52% increase in the number of new registrations compared to the number of electors that had dropped off following the canvass in 2017. Full increases in the electorate figures would be presented to the next Committee.

It was reported that there had been a lot of engagement in Smethwick, however some had chosen not to respond to letters and had been removed. Some individuals were not aware that they are eligible to vote and officers intend to meet with community leaders to address this.

Members were notified that it was an offence not to return the Household Enquiry Form but not an offence to decline to register.

Members proposed that a fine be imposed for not returning the Household Enquiry Form and asked that the possibility of a penalty being incurred for refusing to register could be imposed. Officers would confirm if and how this could be undertaken with the Council's legal officers.

The canvass at the beginning of August delivered 134,200 initial Household Enquiry Forms and the response rate was currently at 82% compared with 69% at this point last year. So far 8000 Invitations to Register had been issued and these potential electors would be followed up to ensure that they registered.

Member were advised that there had been a successful response to telephone canvassing and this was a cost effective method of engagement.

Engagement via radio advertisements on Raj radio had been positive. This method was intended to reach low responding areas where language barriers may have been an issue.

Social Media platforms showed videos on how to respond to forms.

The communications team had considered how to promote the message to the right people. The Electoral Participation Officer had been invited to speak at a National event.

It was noted that despite efforts there had been lack of response from people with Gambian and Sudanese background. The Right Honourable John Spellar MP would be visiting the Gambian Centre in the near future and would discuss this matter with the Gambian community leaders.

Issues in respect of Houses of Multiple Occupancy meant that an accurate data set was difficult to capture and people moved on a regular basis. Private Landlords should have a duty to see that HEF's were returned.

The canvass at the beginning of August delivered 134,200 initial Household Enquiry Forms and the response rate was currently at 82% compared with 69% at this point last year. Single occupancy forms would be investigated to ensure that 16 and 17 year olds listed at the properties would be followed up.

It was suggested that registration forms could be distributed at schools and colleges.

Town Champions/ambassadors was a suggestion at the last Committee meeting and officers were making arrangements.

An analysis of those in receipt of Housing benefit and the level of registration along with a snapshot of private housing would be developed.

The Electoral Services Manager would investigate if the travelling community with a permanent base had been included within the Canvass.

The Committee thanked Elections team for all their commitment and the work undertaken so far.

### **Progress Briefing**

### 1. Actions from last meeting

- 1.1 Action: Members proposed that a fine was imposed for not returning the Household Enquiry Form (HEF) and asked that the possibility of a penalty being incurred for refusing to register could be imposed. Officers would confirm if and how this could be undertaken with the legal department of the Council.
- 1.2 Progress: Under Individual Electoral Registration (IER) a civil penalty may be imposed on those who have been issued with a requirement to register notice and failed to register by the date stated in the notice. The amount of the Civil Penalty is currently £80. Any costs associated with the enforcement of the Civil Penalty notice are paid by the Local Authority. Any money that is collected as a result of the Civil Penalty must be returned to Cabinet Office to be paid into the consolidated fund.

Penalty for failure to respond to a HEF: By law a person who has received a Household Enquiry Form must provide the information that is required to the Electoral Registration Officer (ERO), whilst there is no requirement for the form itself to be returned, there is a criminal penalty of a fine up to a maximum of £1000 for failing to provide the information. Again unless specified by the court any costs associated with this are to the Local Authority.

In both cases due to the processes associated with IER any form of prosecutions would involve a significant workload with and financial gains being returned to Cabinet Office.

- 1.3 Action: An analysis of those in receipt of Housing Benefit and the level of registration along with a snapshot of private housing would be developed.
- 1.4 Progress: Officers are in discussion with the relevant Directorate. The Annual canvass has now concluded so officers will now be able to concentrate on the data matching and investigation exercise. The Elections team will provide a further update on this.

### 2. Canvass and Publication of the Revised Register.

### 2.1 HEF Responses

The revised register was published on 1 December. Officers are extremely pleased with the results of this year's canvass activities. The response rate for the HEF is 93% (125,500) properties for this year, compared to 82% (108,500) for last year's canvass. The number of non-responding properties this year is 8600. Officers have established that of the 8600 properties that have not responded 3,100 have been confirmed as "void/empty" from council tax matching. This means that 4% of properties across the borough have not responded as opposed to 19% last year. Officers would advise that the increase in response rate this year has been delivered with a significant saving of £24,450 compared to last year's canvass.

### 2. 2 Invitations to Register

It is important to note that under the IER registration system, responses to the HEF do not result in automatic registrations. Currently there are 6500 outstanding Invitations to register across the borough that have not been included in the 1 December register. Pending electors are the elections team priority all year round and the focus from December to March will be to encourage and obtain registrations ahead of the May elections.

### 2.3 Electorate 1 December

The electorate as at 1 December is 221,258. A breakdown of electorate per ward has been shown in Appendix A. During the canvass the elections team administered 20,918 amendments to the register which has resulted in an increase of 2800 electors overall. Officers are very encouraged by this response and pleased with the responses to the new initiatives introduced this year. There are currently 21,971 postal voters within the borough that equates to 9.9% of the electorate. The current number of electors that have opted out the open register is 103, 450 which is 46.7%.

### 2.4. Summary of canvass activities

At the last meeting of the committee officers presented a report which detailed the initiatives undertaken for this year's canvass. Significant results have been seen this year not only in terms of increasing the electorate but also ensuring that the register is accurate which is also vitally important. Sandwell has a very transient population and this is demonstrated by the numbers of amendments to the register. This is why the need to interrogate and use existing data files from existing council resources is so important and will continue to form a critical part of the services engagement framework moving forward. At the next meeting of the Committee an update will be provided as to the results from the data matching initiatives.

### **Voting in Sandwell**

School Elections have been held at George Betts, Uplands and Lyng Primary with Q3 Langely to hold theirs in the next couple of weeks.

Latvian General Election: This was the first time this was held in Sandwell at Thimblemill Library 450 votes were cast at the Polling Station we will now be working with Sakta the community group with regards to workshops around Electoral Participation.

### Vision 2030 Voting

As part of the Vision 2030 Consultation we have facilitated 5 schools to vote on their top 3 priorities again setting up Polling Stations within the school and running it similar to real life election with well over 2000 students participating in this, without the strong links developed through the Electoral Participation work with the schools the Council would not have been able to run the workshops or held the consultation/vote in such a guick time frame

### **National Reputation**

The work that we have done in both the Community and Schools is nationally recognised as good practice over 10 councils across the country have asked for advice and assistance on ideas on how to engage with schools and the community by AEA, Electoral Commission and Cabinet Office.

The Minister of the Constitution and the Cabinet Office have visited us in Sandwell and have asked for our opinion on policy on areas of the Canvass review and ID.

Parliament Week and National Democracy Week regularly celebrated with great success in Sandwell with high levels of social media engagement as well.
