#### 1. Recommendations

- 1. To consider the application for the grant of a new premises licence under section 17 of the Licensing Act 2003 in respect of Muncheese, 49 Hobs Road, Wednesbury, WS10 9BL.
- 2. Each application must be considered on its merits taking into account the evidence presented at the hearing, and the Guidance issued under Section 182 of the Licensing Act 2003 and the Council's Licensing Policy. The options that can be considered once evidence has been heard are detailed at section 5.

#### 2. Reasons for Recommendations

2.1 The Licensing Sub Committee is asked to make a decision on the application based on any evidence presented at the hearing taking into account the Guidance issued under Section 182 of the Licensing Act 2003 and the Council's own Statement of Licensing Policy and to give reasons for their decision.



2.2 To consider an application for the grant of a new premises licence in respect of Muncheese, 49 Hobs Road, Wednesbury, WS10 9BL, following receipt of a representation from a local resident objecting to the grant of the application due to concerns that some of the four licensing objectives would be undermined, those specifically being the Prevention of a Public Nuisance.

### 3. How does this deliver objectives of the Corporate Plan?

## A strong and inclusive economy

Investing in people and jobs. Licensed premises provide employment in the Borough and help to support the Borough's economy.

It is the Authority's aim to offer a wide choice of high quality and well managed entertainment and cultural venues within a safe, orderly and attractive environment; valued by those who live here, work here and come to visit. We want to ensure that businesses operate responsibly and safely so that our residents live in decent neighbourhoods and have a good quality of life.

#### 4. Context and Key Issues

- 4.1 Under the Licensing Act 2003, a responsible authority or any other person may make representations in respect of the application which must be relevant to one or more of the four licensing objectives, namely:
  - o The Prevention of Crime and Disorder
  - o Public Safety
  - The Prevention of Public Nuisance
  - The Protection of Children from Harm
- 4.2 Representations has been received from interested persons, the copy of the representations are attached at Appendix 3

## **CURRENT POSITION**

- 4.3 An application has been made by SV Muncheese Limited for the grant of a new premises licence.
- 4.4 A copy of the full application is attached at Appendix 1.



- 4.5 The application is for Late Night Refreshment (Outdoors) Monday Sunday 23:00 – 03:00.
- 4.6 The proposed hours the premises will be open to the public is Monday Sunday 11:00 – 00:00. The premises will be open for collection until 00:00 and from 00:00-03:00 orders will be for delivery only.

#### 4.7 Operating Schedule/Proposed Conditions

#### General

The premises will be open for collection until 00:00 and from 00:00-03:00 orders will be for delivery only

### The prevention of crime and disorder

CCTV – It will be digital recorded for up to 31 days and will be made available on request to all licensing authorities. There will be a member of staff on duty who is trained and able to show and download images from the system during opening hours. It will be in recording operation during opening hours and it will cover all licensable activity areas of the premises.

The offence provisions of the Licensing Act 2003 (ss145 - 153) apply to the premises. Crime, disorder, public safety and public nuisance will be contained by trained members of staff, should any incident occur, the responsible authority will be notified. The premises will have at least one member of staff who shall be trained in first aid.

#### **Public Safety**

The premises licence holder shall ensure signage will be put up to state any persons causing a nuisance, fight or any drug- related offences will be banned from the premises. Should any serious incidences occur members of staff will notify the responsible authority.

The premises licence holder shall maintain an incident log.

The premises licence holder shall maintain a refusals log.



## The prevention of public nuisance

Noise – The premises licence holder shall ensure that noise levels arising from the premises are at a level as not to disturb local residents.

Signage – Signage displaying to customers 'Respect Local Residents, please leave quietly' shall be displayed around location and at the exits.

The premises shall conclude licensable activity each day at 00:00 hours except for deliveries which will conclude at 03:00 hours each day. Delivery drivers will wait for their order inside the premises and not sit in/on their vehicles. Delivery drivers will not keep their engines running while outside the premises. Deliver drivers will not play music audible form outside their vehicle while outside premises.

#### The Protection of children from harm

No licensable enforceable conditions have been identified.

4.8 A location map of the premises is attached at Appendix 2.

## 4.9 **Consultation (customers and other stakeholders)**

A notice has been published in a local paper and a public notice has been displayed at the premises outlining the application and inviting comments/representations to be sent to the Licensing Authority, detailing a closing date for these to be received. Details of the application were also published on the Council's website.

## 5. Alternative Options

- 5.1 The options available to the Licensing Sub-Committee having considered all the relevant information are as follows:
  - to grant the licence subject to conditions consistent with the operating schedule accompanying the application, and any mandatory conditions which must be included in the licence
  - to exclude from the scope of the licence any of the licensable activities to which the application relates;



- to refuse to specify a person in the licence as the premises supervisor;
- to reject the application
- 5.2 Conditions may be altered or omitted, or any new condition added.
- 5.3 Additional conditions or restrictions to licensable activities and/or times should only be imposed if considered appropriate for the promotion of the licensing objectives. If other law already places certain statutory responsibilities on a premise, it would not be appropriate to impose similar duties.
- 5.4 Members of the Sub Committee should be advised that the applicant, or any other person who made relevant representations in relation to the application, may appeal against the decision made to the Magistrates' Court within 21 days of the date on which they were notified.

#### 6. Implications

Legal and Governance:	Members of the Licensing Sub Committee when making their decision on the application must take into account the four licensing objectives, the Guidance issued under Section 182 of the Licensing Act 2003 and the Council's own Statement of Licensing Policy. The applicant and those who have made relevant representations have the right to appeal the decision made by the Licensing Sub Committee to the Magistrates Court, so the Committee are asked to give reasons for their decision wherever possible. Members of the Sub-Committee should not allow themselves to predetermine the application or to be


