6/22 Review of a Hackney Carriage Driver's Licence in respect of Mr M H

Members considered a review of the Private Hire and Hackney Carriage Driver's Licence in respect of Mr M H.

Mr M H was in attendance at the meeting, accompanied by a family member for support, and had not previously appeared before the Licensing Sub Committee.

Mr M H explained the medical issue he was experiencing at the time, it was confirmed however, that he did not have a diagnosed medical condition and did not have any medical reports or letters that could be provided. The Sub Committee was advised that Mr M H had been invited to attend the Committee meeting following a complaint that indicated inappropriate behaviour whilst holding a hackney carriage driver's license, namely urinating in a public place.

The Sub Committee were aware that the supermarket nearby contained a toilet that was available for public use at all times during opening hours, however, during the pandemic period appreciated that it would be difficult to gain access due to queuing.

It was clarified that the officer who reported the incident had done so as a member of the public and not in his capacity as an officer of the Council.

Mr M H advised that he now had a contingency plan to prevent the incident occurring again in the future.

The Sub Committee took advice from its Legal Advisor before adjourning to make a decision on the application.

The Sub Committee took into consideration representations made by all parties and members decided, on the balance of probabilities, that Mr M H was a fit and proper person to hold a licence.

Having considered all the information before them, the decision was made to issue a written warning to Mr M H with regard to his future conduct when working as a licensed driver, Members were of the view that this was appropriate given the nature of the issue and the driver's longstanding clean record.

Resolved that Mr M H be warned with regard to his future conduct when working as a licensed driver.

In making the decision the Committee had regard to the Local Government (Miscellaneous Provisions) Act 1976, Council Policy and Guidelines, relevant case law and the Human Rights Act 1998.

1 Recommendations

1.1 To consider the application (Appendix 1) made by Mr Stephen Leinster for the renewal and transfer of a sex shop licence in respect of Private Shop, 19 Bull Street, West Bromwich, B70 6EU.

2 Reasons for Recommendations

2.1 The Licensing Sub Committee is asked to make a decision on the application based on any evidence presented at the hearing taking into account the Guidance issued under Schedule 3 of the Local Government (Miscellaneous Provisions) Act 1982 and the Council's Licensing Policy and to give reasons for their decision.



A strong and inclusive economy Investing in people and jobs. Licensed premises provide employment in the Borough and help to support the Borough's economy.

It is the Authority's aim to offer a wide choice of high quality and well managed entertainment and cultural venues within a safe, orderly and attractive environment; valued by those who live here, work here and come to visit. We want to ensure that businesses operate responsibly and safely so that our residents live in decent neighbourhoods and have a good quality of life.

4 THE CURRENT POSITION

- 4.1 The premises have traded as a licensed sex shop at these premises since 2003 and the licence has been renewed each year.
- 4.2 At its meeting on 23rd September 2008 the committee gave approval for a limited form of open window display at the premises for the display of lingerie on mannequins but nothing of a sexual nature.
- 4.3 Mr Stephen Leinster has worked as the regional co-ordinator for the existing licensee (Darker Enterprises Limited) since 2008 and is taking on some shops that are currently in their portfolio. Mr Leinster is also keeping most of the existing staff.
- 4.4 If the licence is renewed and transferred, it will run for a period of 12 months commencing 1st August 2022 and will expire on 31st July 2023.
- 4.5 A copy of the current licence and conditions are attached for information as Appendix 2.
- 4.6 A map of the area showing the location of the licensed premises is attached for information as Appendix 3.



4.7 If approved, the licence will run for a period of 12 months.

5 CONSULTATION (CUSTOMERS AND OTHER STAKEHOLDERS)

- 5.1 The applicant has complied with all the statutory requirements with regard to the application process.
- 5.2 The applicant is required to advertise the application in a paper circulating in the vicinity of the premises within 7 days of submitting the application and to also display a public notice outside the premises for 21 days. The public notice was placed in the Express and Star on 15 July 2022 and the applicant has confirmed that the public notice was displayed on or near the premises from 15 July 2022 to 5 August 2022.
- 5.3 No objections have been submitted by West Midlands Police and no other objections have been received for this application.

6. ALTERNATIVE OPTIONS

- 6.1 The grant, renewal and transfer of sex establishment licences are subject to the provisions of Schedule 3 of the Local Government (Miscellaneous Provisions) Act 1982.
- 6.2 An application for grant/renewal/transfer may be refused on one or more of the following grounds:
- 6.2.1 The applicant is unsuitable to hold the licence by reason of having been convicted of an offence or any other reason.
- 6.2.2 That if the licence were to be renewed, the business to which it relates would be managed by, or carried on for the benefit of a person other than the applicant who would be refused the renewal of the licence if he made the application himself.
- 6.2.3 That the number of sex establishments in the relevant locality at the time the application is determined is equal to or exceeds the number



which the Panel considers is appropriate for that locality.

- 6.2.4 That the renewal of the licence would be inappropriate, having regard to
 - The character of the relevant locality
 - The use to which any premises in the vicinity are put
 - The layout, character or condition of the premises in respect of which the application is made.
- 6.3 An applicant whose application for renewal is refused on any of the grounds specified in paragraphs 6.2 above does not have the right to appeal that decision. In such cases, the applicant could only challenge the Panel's decision by way of judicial review.
- 6.4 An applicant must be given the opportunity of appearing before the body making the decision before an application is refused.

 - (b) "The premises" means the premises described above in respect of which this licence is granted.
 - (c) "The Act" means the Local Government (Miscellaneous Provisions) Act 1982.
- 2 This Licence is granted in respect of a sex shop only as defined in the Act and the premises shall not be used as a sex cinema as defined in the Act without the issue of a further licence by the Council.
- 3 Unless otherwise provided for by paragraph 14 below, the premises shall not be opened or used for the purpose for which the licence is granted before the hour of 9.00am in the morning or after the hour of 6.00pm in the afternoon of any weekday including Saturday.
 - (ii) The premises shall not be opened on Christmas Day.
- 4 No refreshment of any kind shall be served or sold to or consumed by customers or potential customers visiting the premises or to or by any person thereupon other than bona fide staff employed upon the premises.
- 5. Facilities for previewing films may be permitted subject to the following
 - a) Any screen(s) shall be placed in such a position so as not to be visible to the public outside the premises.
 - b) Only video clips of other videos for advertising purposes shall be shown and no individual clip shall be shown for longer than 3 minutes.
 - c) No film or movie will be shown in its entirety.
 - d) Films or video clips will not be shown at the customer's request
- 6 The licensee or any person acting or purporting to act on his behalf shall be responsible for ensuring that the conditions of the Licence are complied with and will be held responsible for any breach thereof.
- 7 Admission shall be given at all reasonable times to the Police and to authorised officers of the Council.
- 8 No person under the age of 18 shall be admitted to the premises at any time.
- 9 No person under the age of 18 shall be employed in the business carried out at

the premises.

10 (i) The interior of the premises shall not be visible to passers-by and the licensee shall obscure all windows and doors in a colour and manner satisfactory to the Council;

(ii) Except as agreed in writing with the Council, the windows, doors, fascia board and all external parts of the premises including the roof shall not contain any form of writing, sign or display, except for:

- (a) the address of the premises;
- (b) the name of the premises;
- (c) a notice, which shall be displayed in a prominent position on each entrance to the premises so as to be readily visible to any person approaching the premises with a view to entering therein but without their having so to enter containing the wording as prescribed by Section 1(6) Indecent Displays Control Act 1981, which is as follows:-

WARNING

Persons passing beyond this notice will find material on display which they may consider indecent. No admittance to person under 18 years of age.

(d) a notice stating the opening hours of the sex shop;

and

(e) the wording "Private Shop" or "Adult Shop" but no other indication as to the nature of the business carried on at the premises.

(iii) In the case of items No's.10(ii) (a),(b),(c),(d) and (e) the lettering used shall be of such colour and style as may be approved by the Council. In the case of items No's. 10(ii) (a),(b) and (e) the lettering shall not exceed one foot in height for each letter.

The Licensing (Miscellaneous) Committee, at its meeting on 23rd September 2008 gave approval for a limited form of open window display at the premises for the display of lingerie on mannequins but nothing of a sexual or explicit nature.

11 No alteration of any kind shall be made to the interior or the exterior of the premises including any change in the permitted signs displayed thereat or in the manner in which the windows and doors are obstructed unless the licensee shall first obtain the written consent of the Council. 12 (i) The licensee shall at all times keep and maintain at the licensed premises a written record of the names, addresses and dates of birth of all persons employed at the premises whether upon a full or part time basis and shall upon request by an authorised officer of the Council make such records available for inspection to him,

(ii) The licensee shall at all times provide the Council with written notification as to the Names, addresses and dates of birth of such person or persons whether employees or otherwise connected with the business who have authority to manage the premises in the licensee's absence.

- 13 The Council may at any time waive, modify or vary these conditions or impose additional restrictions in any particular case.
- 14 The premises are allowed to remain open on Fridays until 8.00pm. Additional permission is given for the premises to remain open until 8.00pm from Monday to Thursday and Saturday during the 2 weeks preceding Christmas each year. The premises are allowed to open on Sundays and Bank Holidays between the hours of 10.00am and 4.00pm.
- 15 All pre-recorded video tape cassettes sold or offered for sale or hire at the premises must:-


(a) have a valid British Board of Film Classification Certificate and be marked accordingly, excluding those which are exempt from certification.

(b) be labelled on the cassette, packaging and any related promotional material only with the title under which the British Board of Film Classification Certificate was issued.

(c) not display any pictorial material which did not form part of the video tape itself, unless the front of the video cover contains a sticker, of the size agreed with the Licensing Authority, which states the following disclaimer:-

'The cover of this video does not necessarily depict the film within.'



4 Context and Key Issues

- 4.1 Section 51 of the Act provides that a district council shall on receipt of an application from any person for the grant to that person of a licence to drive private hire vehicles, grant to that person a licence:
 - a) unless they are satisfied that the applicant is not a fit and proper person for the grant to that person of a licence to drive private hire vehicles, grant to that person a licence;
 - b) to any person who has not for at least twelve months been, and is not at the date of application for a driver's licence, the holder of a licence granted under part III of the Act of 1972, 1988 (not being a provisional licence) authorising him to drive a motor car.
- 4.2 Section 61 (1) of the Act states that a district council may suspend, revoke or refuse to renew a private hire/hackney carriage driver's licence on any of the following grounds:
 - a) the holder has, since the grant of the licence;
 - i) been convicted of an offence involving dishonesty, indecency or violence, or



- ii) been convicted of an offence or failed to comply with the provisions of this part of the Act, or
- iii) any other reasonable cause.

(2A) Subject to subsection (2B) of this section, a suspension or revocation of the licence of a driver under this section takes effect at the at the end of the period of 21 days beginning with the day on which notice is given to the driver under subsection (2)(a) of this section.

(2B) if it appears that the interest of public safety requires the suspension or revocation of the licence to have immediate effect, and the notice given to the driver under subsection (2)(a) of this section includes a statement that is so and an explanation why, the suspension or revocation takes effect when the notice is given to the driver.

4.3 Section 48 of the Act states that a district council may on the receipt of an application from the proprietor of any vehicle for the grant in respect of such vehicle of a licence to use the vehicle as a private hire vehicle, grant in respect thereof a vehicle licence:

Provided that a district council shall not grant such a licence unless they are satisfied:-

- (a) that the vehicle is:-
 - (i) suitable in type, size and design for use as a private hire vehicle;
 - (ii) not of such design and appearance as to lead any person to believe that the vehicle is a hackney carriage;
 - (iii) in a suitable mechanical condition;
 - (iv) safe; and
 - (v) comfortable;
- (b) that there is in force in relation to the use of the vehicle a policy of insurance or such security as complies with the requirements of part VI of the Act of 1972.



Section 55 of the Act states:-

(1) Subject to the provisions of this Part of this Act, a district council shall, on receipt of an application from any person for the grant to that person of a licence to operate private hire vehicles grant to that person an operator's licence:

Provided that a district council shall not grant a licence unless they are satisfied that the applicant is a fit and proper person to hold an operator's licence.

(2) Every licence granted under this section shall remain in force for such period, not being longer than five years, as a district council may specifyin the licence.

(3) A district council may attach to the grant of a licence under this section such conditions as they may consider reasonably necessary.

(4) Any applicant aggrieved by the refusal of a district council to grant an operator's licence under this section, or by any conditions attached to the grant of such a licence, may appeal to a magistrates' court.

4.4 Section 56 of the Act states:-

(1) For the purposes of this Part of this Act every contract for the hire of a private hire vehicle licensed under this Part of this Act shall be deemed to be made with the operator who accepted the booking for that vehicle whether or not he himself provided the vehicle.

(2) Every person to whom a licence in force under section 55 of this Act has been granted by a district council shall keep a record in such form as the council may, by condition attached to the grant of the licence, prescribe and shall enter therein, before the commencement of each journey, such particulars of every booking of a private hire vehicle invited or accepted by him, whether by accepting the same from the hirer or by undertaking it at the request of another operator, as the district council may by condition prescribe and shall produce such record on request to any authorised officer of the council or to any constable for inspection.



(3) Every person to whom a licence in force under section 55 of this Act has been granted by a district council shall keep such records as the council may, by conditions attached to the grant of the licence, prescribe of the particulars of any private hire vehicle operated by him and shall produce the same on request to any authorised officer of the council or to any constable for inspection.

(4) A person to whom a licence in force under section 55 of this Act has been granted by a district council shall produce the licence on request to any authorised officer of the council or any constable for inspection.

(5) If any person without reasonable excuse contravenes the provisions of this section, he shall be guilty of an offence.

- 4.5 Section 62(1) of the Act states a district council may suspend or revoke, or (on application therefore under section 55 of this Act) refuse to renew an operator's licence on any of the following grounds:-
 - (a) any offence under, or non-compliance with, the provisions of this Part of this Act;
 - (b) any conduct on the part of the operator which appears to the district council to render him unfit to hold an operator's licence;
 - (c) any material change since the licence was granted in any of the circumstances of the operator on the basis of which the licence was granted; or
 - (d) any other reasonable cause.
- 4.6 Section 60 of the Act states that a district council may suspend or revoke or refuse to renew a vehicle licence on any of the following grounds:-
 - (a) that the hackney carriage or private hire vehicle is unfit for use as a hackney carriage or private hire vehicle;
 - (b) any offence under, or non-compliance with, the provisions of the Act of 1847 or of this part of this Act by the operator or driver; or
 - (c) any other reasonable cause.



- 4.7 Individual case details are appended which refer to unspent convictions. Unspent convictions are those not covered by the Rehabilitation of Offenders Act 1974.
- 4.8 If an application is refused, suspended or revoked the applicant has the right of appeal to the Magistrates Court.
