1 Recommendations

- 4.1 Former Councillor Mohinder Singh Tagger served on Sandwell Metropolitan Borough Council for 26 years, he had served as the Deputy Mayor for the Municipal Year 2006- 2007, had held the position of Vice-Chair for Licensing Committee and Scrutiny Boards for a number of years.
- 4.2 The Committee considered his additional contributions to the Borough of Sandwell through his various charitable, community and voluntary activities and concluded that he fulfilled the eminent service criteria associated with the honour.
