The Mayor gave details of Mayoral and Deputy Mayoral engagements that had taken place.

The Chief Executive welcomed Mike Jones as the new Monitoring Officer.

The Chief Executive welcomed and congratulated Joshua Singh following his accomplishment of winning the National Young Planner of the year 2023 award.

The Chief Executive announced that the Sandwell Transition Education Partnership Service (STEPS) and Youth Service, along with partners, had walked away with two wins in their respective categories at the November Children and Young People Now Awards 2023. STEPS had become the first winner of Children and



Young People Now - New Supporting Child Refugees Award. Colleagues had also won the Partnership Working Award for their work on Sandwell County Lines Intensification Week led by Sandwell Children's Trust's Horizons Exploitation and Missing Team.

The Mayor gave details on the Anchor Network Partnerships Charter. The Partnership was facilitated by the Council, comprising local anchor organisations" who had an importance presence in Sandwell due to being largescale employers and purchases of goods and servicesBy signing the Sandwell Anchor Network Partnership Charter, the Council would lead the way by example. The Cabinet Member for Regeneration and WMCA also commented on the network before signing the Charter.

136/23 **Designation of Interim Statutory Chief Officer**

Brendan Arnold was appointed to the role of Interim Finance Director in September 2023 under delegated powers. The interim designation as Chief Officer/Section 151 Officer required confirmation from Full Council. The Council had a statutory



obligation to designate an individual as Section 151 Officer as required by s.151 of the Local Government Act 1972.

Resolved that Brendan Arnold, the Council's Interim Finance Director, is designated as the Council's Section 151 Officer/Chief Finance Officer.

137/23 Sandwell Council Improvement Plan

On 22 March 2022, the Secretary of State for Levelling Up, Housing and Communities announced an intervention package and a set of Directions to ensure the Council was able to comply with its best value duty under Part 1 of the Local Government Act 1999. These Directions were in-part influenced by the Grant Thornton report following their Value for Money Governance Review of December 2021. A single Improvement Plan was agreed by Council on 7 June 2022.

Under the Statutory Directions, the Council was required to report progress against the Improvement Plan to the Department of Levelling Up, Housing and Communities every six-months following approval of the Plan. The first report was submitted in December 2022 and the second report had been submitted in June 2023. The next report for submission was due in December 2023.

The Leader outlined the progress that had been made in delivering the actions contained within the Improvement Plan and provided an update on Cabinet's recommendation to Council.

Resolved that the Improvement Plan Progress Reports and an accompanying letter are submitted to the Secretary of State for Levelling up, Housing and Communities to form the Council's six-monthly update on progress against the Improvement Plan.



138/23 Code of Corporate Governance

The Council was responsible for ensuring that its business was conducted in accordance with the law and proper standards, that public money was safeguarded, properly accounted for and used efficiently and effectively and that robust governance arrangements were in place. The Council had adopted the Local Code of Corporate Governance as a mechanism to demonstrate that the Council's governance structures complied with the principles contained in the framework.

As part of its commitment to ensuring that the governance infrastructure remained appropriate, the Council undertook a review of its arrangements and updated the Code accordingly.

The Audit and Risk Assurance Committee had considered the refreshed Code of Corporate Governance at its meeting on 23 November 2023 and recommended the matter to Full Council for approval.

Resolved that the updated Code of Corporate Governance is approved.



139/23 Consideration of Special Responsibility Allowance for Shadow Cabinet Members

The Council was required by the Local Authorities (Members' Allowances) (England) Regulations 2003 to undertake periodic reviews of its Scheme of Members' Allowances.

In 2022, the Independent Remuneration Panel met with members to seek views on the introduction and operation of a shadow cabinet member role and considered benchmarking data. The Panel subsequently recommended to Council on 23 May 2023 that the issue of formally recognising a shadow cabinet was a matter for Council and should the Council wish to progress this issue, it would be the Panel's recommendation that the roles should be afforded an allowance equivalent to 10% of the Leaders allowance. The Governance and Constitution Committee met on 21 September 2023 and set up a working group to consider a Shadow Cabinet protocol. The protocol was subsequently approved by the Chair of the Committee in October 2023 and was considered and approved by Council on 24 October 2023.

The Independent Remuneration Panel met on 6 November 2023 to consider whether any SRA should be applied to the shadow cabinet member roles. The Panel considered the Shadow Cabinet Protocol which provided clarity on the role of shadow cabinet members; benchmarking data of other local authorities which identified whether other local authorities had a shadow cabinet and whether there was an allowance attached to the role. The Panel was of the view that a Special Responsibility Allowance should be payable to Shadow Cabinet Members, to be set at 10% of the Leader's Allowance (i.e. £2,858.40), where the size of the majority opposition group remains at 5% and above of the size of the controlling group.



Councillor Piper moved the following amendment to the Motion, seconded by Councillor Carmichael:-

"Full Council notes and endorses the principles set out in the recommendations of the Independent Remuneration Panel in relation to the payment of a Special Responsibility Allowance (SRA) to members of a Shadow Cabinet drawn from the largest qualifying opposition group only, subject to the threshold for payment being set at 15% of the overall Council size, giving a current threshold of 11"

The amendment was accepted, the amended motion was put to the vote and it was **Resolved** that a Special Responsibility Allowance of 10% of the Leader's Allowance is approved for Shadow Cabinet Members, providing the size of the largest opposition group membership equates to at least 15% of the membership size of the controlling political group on the Council.

140/23 Proposed Departure from the Development Plan at West Midlands Foundry Co Limited, Blakemore Road, West Bromwich

Planning Committee had granted conditional approval at its meeting held on the 25 October 2023 in relation to DC/23/68467 (proposed 2 No. portal framed buildings to house 7 No. small units for general industrial/storage and distribution use with associated vehicle access, substation, sliding front gates, parking and covered cycle shelter) at West Midlands Foundry Co Limited, Blakemore Road, West Bromwich.

The site was initially a residential allocation and the proposed development would infill a vacant yard within an existing industrial estate. It was necessary for the Council to consider whether or not



to grant an exception to adopted policy to allow the application to proceed.

Resolved that approval is given to an exception to the Development Plan in respect of planning application DC/23/68467 (proposed 2 No. portal framed buildings to house 7 No. small units for general industrial/storage and distribution use with associated vehicle access, substation, sliding front gates, parking and covered cycle shelter) – West Midlands Foundry Co Limited, Blakemore Road, West Bromwich.

141/23 Proposed departure from the Development Plan at Locarno Works, Locarno Road, Tipton

Planning Committee had granted conditional approval at its meeting held on the 29 November 2023, which considered planning application DC/23/68518 (Retention of light industrial and storage use, vehicular access, car and vehicle parking, lighting and CCTV).

The site was currently a residential allocation and the proposed development would make use of a yard within an existing industrial estate. It was necessary for the Council to consider whether or not to grant an exception to adopted policy to allow the application to proceed.

Resolved that approval is given to an exception to the Development Plan in respect of planning application DC/23/68518 (Retention of light industrial and storage use, vehicular access, car and vehicle parking, lighting and CCTV) at Locarno Works, Locarno Road, Tipton.



142/23 Proposed departure from the Development Plan at Tata Cargo Ltd, Rigby Street, Wednesbury, WS10 0NP

Planning Committee had granted conditional approval at its meeting held on 25 October 2023, which considered planning application DC/22/67520 which sought approval for the retention of heavy goods lorry and trailer parking area with portable office at the site of Tata Cargo Ltd in Wednesbury.

The site was currently allocated for housing under the Site Allocations and Delivery Development Plan Policies Map. It was necessary for the Council to consider whether or not to grant an exception to adopted policy to allow the application to proceed.

Resolved that approval is given to an exception to the Development Plan in respect of planning application DC/22/67520 - Retention of heavy goods lorry and trailer parking area with portable office at the site of Tata Cargo Ltd, Rigby Street, Wednesbury, WS10 0NP.



143/23 Proposed departure from the Development Plan at land at the corner of Cleton Street and Sedgley Road East/Tipton Road, Tipton

Planning Committee had granted conditional approval at its meeting held on 29th November 2023, which considered planning application DC/23/68624 which sought approval for 2 no. detached light industrial units with new access, parking, landscaping and new retaining wall with railings to rear.

The site was currently allocated for housing under the Site Allocations and Delivery Development Plan Policies Map. It was necessary for the Council to consider whether or not to grant an exception to adopted policy to allow the application to proceed.

Resolved that approval is given to an exception to the Development Plan in respect of planning application DC/23/68624 - Proposed 2 No. detached light industrial units with new access, parking, landscaping and new retaining wall with railings to rear at land at corner of Cleton Street and Sedgley Road East/Tipton Road, Tipton.



144/23 Planning Delegations Agreement

The Council's planning delegations agreement was last reviewed in 2012. The purpose of the planning delegations agreement was to ensure that planning applications are determined in an open and transparent manner.

Local planning authorities were closely monitored by the Government regarding the time taken to determine planning applications. The revised planning delegations agreement had been updated to align with new legislation and Council structure, clarify the reasons for reporting a planning application to the Planning Committee and to remove the need to report certain planning applications to the Committee that were not controversial.

Resolved that the revised planning delegations agreement is approved.

145/23 **Political Balance of Committees and Boards**

Council considered the political balance of the committees, boards and other fora for the remainder of the 2023-2024 municipal year.

Resolved that the political balance of the committees, boards and other fora for the remainder of 2023-24 be approved.



146/23 **Revisions to Committees, Boards and Other Bodies**

Council considered revisions to the appointments to committees, boards and other bodies.

Resolved that the revisions to appointments to committees, boards and other bodies, as set out in Appendix A, is approved with immediate effect.

147/23 **To receive the minutes of Cabinet**

The minutes of the meetings of the Cabinet held on 18 October and 15 November 2023 were received.

147/23(a) Medium Term Financial Strategy – Autumn 2023

The Local Government Finance Act 1992 required the Council to set a balanced, risk assessed budget each year and approve a Council Tax precept by 11 March.

The current position of the medium-term financial strategy sought approval to commence consultation on a range of potential savings options to support the Council in setting a balanced budget in February 2024.

Resolved that the Autumn 2023 update of the Medium-Term Financial Strategy Update is approved.

147/23(b) Council Tax Base 2024/2025

The Council Tax Base was an assessment required by each billing authority to determine the number of chargeable dwellings, converted to Band D equivalents (the average band), allowing for discounts, exemptions, non-collection and new properties. This information would later be used when setting the Council's budget.

The Council Tax Base was calculated in accordance with the Local Authorities (Calculation of Council Tax Base) (England) Regulations 2012 and used to determine the annual amount of collectable Council Tax.

Resolved that:

- (1) the Council Tax Base of 78,217,27 for 2024/2025 is approved;
- (2) in accordance with (1) above, the Section 151 Officer is authorised to adjust the Council Tax base as required.

147/23(c) Local Council Tax Reduction Scheme 2024/2025

The Local Council Tax Reduction Scheme provided crucial support to low income families and vulnerable residents. Sandwell Council was one of only a few nationally that still provided 100% support towards Council tax.

Resolved that the Local Council Tax Reduction Scheme for 2024/25 is approved.



147/23(d) The review of council tenant rents and housing related property charges

The Council had to achieve the right balance between supporting tenants to mitigate the continued cost of living pressures and protecting the Housing Revenue Account (HRA) to ensure that it could continue to provide affordable social housing for residents.

There was a recognition that the council needed to maintain the existing housing stock to a good standard and cover operational costs and to achieve the right balance between protecting tenants, protecting tax payers and ensuring that the council could deliver on its commitments to build new social homes.

For 2024/25, the government had not announced a rent cap, therefore the council was permitted to increase rents by CPI+1% in line with the Rent Standard and Policy Statement on Rents for Social Housing issued annually in April.

Resolved that the Interim Director of Housing is authorised to adjust council rents and housing related charges with effect from 1 April 2024 as follows:

- (1) that the housing rental charges is increased by 7.7% which is the consumer price index 6.7% (September 2023) plus 1%, which is equivalent to a 7.7% increase;
- that the housing service charges increase by the consumer price index (CPI)+ 1%, equivalent to a 7.7% increase;
- (3) that housing service charge is implemented on properties not currently being charged but are receiving the service in line with similar properties receiving the



service provision, including heating, water and laundry facility following consultation with residents;

- (4) that subject to consultation with the residents of the site, to increase rent at the traveller's pitch in Hills View, Tipton by 7.7%;
- (5) that properties managed by Riverside under the Private Finance Initiative (PFI) agreement receive a 7.7% rental increase and a 7.7% increase in service charges to match the council's rent and service charge increase;
- (6) that properties that sit outside the Housing Revenue Account (including service tenants for Parks, Sandwell Valley and Caretaking) receive a 7.7% increase in rental charges and service charges equivalent to CPI plus 1%;
- that the leaseholder annual management fee is increased by 7.7%, CPI + 1% in 2024/25 from £115.66 to £124.57;
- (8) that the Director of Housing is authorised to implement adjustments to council rents and housing related charges as set out in this report with effect from 1 April 2024; and
- (9) that the Director of Housing is authorised to introduce associated service charges in respect of Building Safety Regulation requirements for Leasehold properties.



147/23(e) 10 Year Business Rates Retention Agreement

Proposals were made for a new agreement with the Department for Levelling Up, Homes and Communities (DLUHC) which allowed the seven West Midlands metropolitan local authorities to retain 100% of their business rates income for the ten years from 2024/25, with a share payable each year to the West Midlands Combined Authority (WMCA) (and 1% payable to the West Midlands Fire and Rescue Authority).

The agreement was in accordance with the "West Midlands Trailblazer Deeper Devolution Deal", which was set out in a paper to Cabinet on 13th September 2023. Cabinet resolved to approve the Deeper Devolution Deal, as set out in the report, and resolved that further reports would be received by Cabinet on specific issues relating to the detail of the Deeper Devolution Deal.

Resolved that:

- approval is granted for the Council to enter into a 10year business rates retention arrangement with the Department for Levelling Up, Homes and Communities (DLUHC), the West Midlands Combined Authority (WMCA) and the six other West Midlands metropolitan local authorities;
- (2) the Director of Finance, in consultation with the Monitoring Officer, is authorised to complete any necessary agreements for the retention arrangement referred to in (1) above;
- (3) the Director of Finance is authorised to make an annual payment to the West Midlands Combined Authority of £1.264m in 2023/24, which constitutes the Council's



proportion of the "WMCA Share" of regional business rates income collected in the current year under the existing 100% business rates retention pilot arrangements and;

(4) subject to approval of recommendation 1.1, the Director of Finance is authorised to make an annual payment to the West Midlands Combined Authority in each year throughout the 10-year period commencing on 1st April 2024, comprising of the Council's proportion of the "WMCA Share" of regional business rates income collected in that year.

149/23(a) Statutory Polling District and Polling Place Review 2023

On 4 December 2023, the General Purposes and Arbitration Committee received a report on the Statutory Polling District and Polling Place Review 2023.

The notice of review was published on 2 October 2023 and the consultation period was from 2 October 2023 to 2 November 2023. All elected members, Members of Parliament, local political parties and local disability and community groups were consulted. The review focused polling stations that required change due to the current venue no longer being available, or due to significant issues with the polling place identified at the local election in May 2023.

Resolved that:-

- the proposed changes to polling districts and polling places, as set out in Appendix B, are approved to take effect at all elections from 2 January 2024;
- (2) The proposed changes to polling places, as set out in Appendix C, are approved to take effect at any future Parliamentary General Elections only; and
- (3) in the event of any or any unforeseen reason, and should there be a need to change any further Polling Places or Polling Stations prior to elections in 2024, the Returning Officer is authorised to effect further changes following consultation with relevant Ward Members.

152/23(a) Modern Slavery

The motion on Modern Slavery was withdrawn.



152/23(b) End Violence Against Women and Girls (White Ribbon Day)

It was moved by Councillor Gill and seconded by Councillor Fisher:-

"Council acknowledges the concerns of women and girls regarding their safety on public transport particularly whilst engaging in the night-time economy and welcomes the work done by local community organisations to raise awareness of violence against women and girls.

Council notes and welcomes the Protection from Sex-based Harassment in Public Bill 2022-23 which introduces a new offence of causing alarm, distress, or intentional harassment to a person in public because of their sex.

Council therefore resolves to -

- Request the Leader of the Council and the Leader of the Opposition write a joint cross-party letter to the Mayor of the West Midlands requesting a progress update on the WMCA's recommendations set out for transport in the Combined Authority's Violence against Women and Girls Strategy.
- 2. Call on all male Councillors to take the White Ribbon pledge, never to take part in, condone or stay silent about violence against women.
- 3. 4. Request that Council mark White Ribbon Day on 25 November each year and encourage participation among Councillors, council staff and local primary and secondary schools"

Can I ask the Cabinet Member what are the main proposed improvements for Sandwell Valley through the masterplan?

7(d) From Councillor Nicky Hinchliff to the Cabinet Member for Children, Young People and Education

I am really pleased to see that is has been agreed to begin the process to make Sandwell a Child Friendly Borough. Can you explain the process and what is involved, and what we as members of the Council can do to support this given we are all corporate parents?

7(e) From Councillor Nicola Maycock to the Cabinet Member for Regeneration and WMCA

The Richard Nugent Centre in Wednesbury had its official launch/opening in December 2023. The centre is a benefit to the town and wider community, with a new Doctors surgery and health centre based here. Can I ask the Cabinet Member advise on what other health facilities are available within the building that will benefit the local community?

7(f) From Councillor Ragih Muflihi to the Cabinet Member for Public Health and Communities

Can I congratulate the Cabinet Member for Public Health and Communities following the Council's recent success in its bid for a £88,000 grant for our neighbourhoods. Can I ask the Cabinet Member what this money will be used for?



7(g) From Councillor Sukhbir Singh Gill to the Cabinet Member for Regeneration and WMCA

As well as residents who live in rented homes, residents who own their own home in Sandwell may also require help or assistance due to the cost of living and extremely high energy costs with the price cap rising from £1834 to £1928 this year. Can the Cabinet Member advise if there is any kind of help or support available from the Council, our partners, the voluntary sector or energy providers offered to contribute towards energy efficiency improvements for home owners in Sandwell?

7(h) From Councillor Jill Tromans to the Cabinet Member for Health and Adult Social Care

This year sees us celebrate the 40th birthday of the Council's community alarms service, a great achievement for the service which provides lifeline to many residents in Sandwell and is a very well thought of service. Can I ask the Cabinet Member to advise whether an alarm for a vulnerable person can be fitted into privately owned or rented homes or in shared accommodation by the service? If not, does the Council signpost residents to other sources of support?

7(i) From Councillor Rizwan Jalil to the Cabinet Member for Environment and Highways

Over recent years, illegal street racing or 'cruising' has been a significant issue for Sandwell and the wider Black Country area. An injunction and enforcement action has proven effective and I would like to thank the cabinet member for his continued involvement in ensuring that Sandwell is part of the Black Country is a 'No cruise Area'.

However, we still have negligent drivers who speed on our roads and I am particularly concerned about neighbourhoods that are built up and have schools in the area. Can I ask the Cabinet Member for Highways if action could be taken to designate all school zones in the borough and in my ward Oldbury as 20mph zones please?



7(j) From Councillor Kalebe-Nyamongo to the Cabinet Member for Public Health and Communities

New figures from the UK Health Security Agency show that there is a rising case of measles across the UK with higher levels seen in the West Midlands. At least 57 suspected cases were reported in the last four weeks of December. There are 167 lab confirmed cases in West Midlands with a further 88 percent likely. Measles is a highly contagious disease caused by a virus. It infects the respiratory tract and then spreads throughout the body. It can cause severe disease, complications, and even death. While measles can affect anyone, it is most common in children. Complications can include chest and ear infections, diarrhoea, encephalitis (infection of the brain) and in severe cases, potential brain damage. Complications are more likely to occur in certain groups including people with weakened immune systems, babies under one year old and pregnant women.

One of the challenges facing health professionals is also that of identifying signs (spots) in people from a minority ethnic background (especially Asians and Black people).

Can the Cabinet Member advise what measures have been put in place in Sandwell to ensure that people are aware of the symptoms/signs and what they can do to protect their children against the disease?

7(k) From Councillor William Gill to the Cabinet Member for Environment and Highways

Across Great Bridge and Tipton, residents have raised their concerns to me about parking over grass verges. This is making areas like the Newtown estate, and Glebefields Road look unsightly and more importantly, it is proving to be a hazard for local people. I've logged numerous cases through the portal and regrettably, it seems to have fallen on deaf ears.

Can the Cabinet Member please explain what steps are the Council taking to tackle the borough-wide issue of damaged grass verges due to parked vehicles?

4. Context and Key Issues

4.1. Treasury Management is defined as "The management of local authority's borrowing, investments and cash flows, its banking, money market and capital market transactions; the effective control of the risks associated with those activities and the pursuit of optimum performance consistent with those risks."



- 4.2. Prudential and Treasury indicators are set and approved before the start of each financial year using information included in the budget reports to inform members of the impact of capital investment decisions and to agree processes for managing risk within the debt and investment strategies.

Treasury Management Strategy Statement and Prudential Indicators Mid-Year Monitoring Report 2023/24

1 Background

1.1 Treasury Management

The Council operates a balanced budget, which broadly means cash raised during the year will meet its cash expenditure. Part of the treasury management operations ensure this cash flow is adequately planned, with surplus monies being invested in low risk counterparties, providing adequate liquidity initially before considering optimising investment return.

The second main function of the treasury management service is the funding of the Council's capital plans. These capital plans provide a guide to the borrowing need of the Council, essentially the longer-term cash flow planning to ensure the Council can meet its capital spending operations. This management of longer term cash may involve arranging long or short-term loans or using longer term cash flow surpluses and on occasion, any debt previously drawn, may be restructured to meet Council risk or cost objectives.

Accordingly, treasury management is defined as:

"The management of local authority's borrowing, investments and cash flows, its banking, money market and capital market transactions; the effective control of the risks associated with those activities and the pursuit of optimum performance consistent with those risks."

2. Introduction

This report has been written in accordance with the requirements of the CIPFA Prudential and Treasury Management (revised 2021).

The primary requirements of the Code are as follows:

- Creation and maintenance of a Treasury Management Policy Statement which sets out the policies and objectives of the Council's treasury management activities.
- Creation and maintenance of Treasury Management Practices which set out the way the Council will seek to achieve those policies and objectives.
- Receipt by the full council of an annual Treasury Management Strategy Statement including the Annual Investment Strategy and Minimum

Revenue Provision Policy – for the year ahead, a Mid-Year Review Report and an Annual Report (stewardship report) covering activities during the previous year.

- Delegation by the Council of responsibilities for implementing and monitoring treasury management policies and practices and for the execution and administration of treasury management decisions.
- Delegation by the Council of the role of scrutiny of treasury management strategy and policies to a specified named body. For this Council the delegated body is the Budget and Corporate Scrutiny Management Board.

This mid-year report has been prepared in compliance with CIPFA's Code of Practice on Treasury Management and covers the following:

- An economic update for the first half of the 2023/24 financial year;
- A review of the Treasury Management Strategy Statement and Annual Investment Strategy;
- The Council's capital expenditure, as set out in the Capital Strategy, and prudential indicators;
- A review of the Council's investment portfolio for 2023/24;
- A review of the Council's borrowing strategy for 2023/24;
- A review of any debt rescheduling undertaken during 2023/24;
- A review of compliance with Treasury and Prudential Limits for 2023/24.

3. Economics and Interest Rates

3.1 Full Economic Update

- The first half of 2023/24 saw:
 - Interest rates rise by a further 100bps, taking Bank Rate from 4.25% to 5.25% and, possibly, the peak in the tightening cycle.
 - Short, medium and long-dated gilts remain elevated as inflation continually surprised to the upside.
 - A 0.5% m/m decline in real GDP in July, mainly due to more strikes.
 - CPI inflation falling from 8.7% in April to 6.7% in August, its lowest rate since February 2022, but still the highest in the G7.
 - Core CPI inflation declining to 6.2% in August from 7.1% in April and May, a then 31 years high.
 - A cooling in labour market conditions, but no evidence yet that it has led to an easing in wage growth (as the 3myy growth of average earnings rose to 7.8% in August, excluding bonuses).

- The 0.5% m/m fall in GDP in July suggests that underlying growth has lost momentum since earlier in the year. Some of the weakness in July was due to there being almost twice as many working days lost to strikes in July (281,000) than in June (160,000). But with output falling in 10 out of the 17 sectors, there is an air of underlying weakness.
- The 0.4% m/m rebound in retail sales volumes in August is not as good as it looks as it partly reflected a pickup in sales after the unusually wet weather in July. Sales volumes in August were 0.2% below their level in May, suggesting much of the resilience in retail activity in the first half of the year has faded.
- As the growing drag from higher interest rates intensifies over the next six months, we think the economy will continue to lose momentum and soon fall into a mild recession. Strong labour demand, fast wage growth and government handouts have all supported household incomes over the past year. And with CPI inflation past its peak and expected to decline further, the economy has got through the cost-of- living crisis without recession. But even though the worst of the falls in real household disposable incomes are behind us, the phasing out of financial support packages provided by the government during the energy crisis means real incomes are unlikely to grow strongly. Higher interest rates will soon bite harder too. We expect the Bank of England to keep interest rates at the probable peak of 5.25% until the second half of 2024. Mortgage rates are likely to stay above 5.0% for around a year.
- The tightness of the labour market continued to ease, with employment in the three months to July falling by 207,000. The further decline in the number of job vacancies from 1.017m in July to 0.989m in August suggests that the labour market has loosened a bit further since July. That is the first time it has fallen below 1m since July 2021. At 3.0% in July, and likely to have fallen to 2.9% in August, the job vacancy rate is getting closer to 2.5%, which would be consistent with slower wage growth. Meanwhile, the 48,000 decline in the supply of workers in the three months to July offset some of the loosening in the tightness of the labour market. That was due to a 63,000 increase in inactivity in the three months to July as more people left the labour market due to long term sickness or to enter education. The supply of labour is still 0.3% below its pre-pandemic February 2020 level.
- But the cooling in labour market conditions still has not fed through to an easing in wage growth. While the monthly rate of earnings growth eased sharply from an upwardly revised +2.2% in June to -0.9% in July, a lot of that was due to the one-off bonus payments for NHS staff in June not being repeated in July. The headline 3myy rate rose from 8.4% (revised up from 8.2%) to 8.5%, which meant UK wage growth remains much faster than in the US and in the Euro-zone. Moreover, while the Bank of England's closely watched measure of regular private sector wage growth eased a touch in

July, from 8.2% 3myy in June to 8.1% 3myy, it is still well above the Bank of England's prediction for it to fall to 6.9% in September.

- CPI inflation declined from 6.8% in July to 6.7% in August, the lowest rate since February 2022. The biggest positive surprise was the drop in core CPI inflation, which declined from 6.9% to 6.2%. That reverses all the rise since March and means the gap between the UK and elsewhere has shrunk (US core inflation is 4.4% and in the Euro-zone it is 5.3%). Core goods inflation fell from 5.9% to 5.2% and the further easing in core goods producer price inflation, from 2.2% in July to a 29-month low of 1.5% in August, suggests it will eventually fall close to zero. But the really positive development was the fall in services inflation from 7.4% to 6.8%. That also reverses most of the rise since March and takes it below the forecast of 7.2% the Bank of England published in early August.
- The Bank of England wants the markets to believe in the higher for longer narrative. Statements from the Bank of England have not said that rates have peaked and once again said if there was evidence of more persistent inflation pressures "further tightening in policy would be required". Governor Bailey stated, "we'll be watching closely to see if further increases are needed". The Bank also retained the hawkish guidance that rates will stay "sufficiently restrictive for sufficiently long".
- This narrative makes sense as the Bank of England does not want the markets to decide that a peak in rates will be soon followed by rate cuts, which would loosen financial conditions and undermine its attempts to quash inflation. The language also gives the Bank of England the flexibility to respond to new developments.

3.2 Interest Rate Movements and Expectations

The Council has appointed Link Group as its treasury advisors and part of their service is to assist the Council to formulate a view on interest rates. The PWLB rate forecasts below are based on the Certainty Rate (the standard rate minus 20 bps) which has been accessible to most authorities since 1st November 2012.

The latest forecast on 25th September sets out a view that short, medium and longdated interest rates will be elevated for some little while, as the Bank of England seeks to squeeze inflation out of the economy. The PWLB rate forecasts below are based on the Certainty Rate (the standard rate minus 20 bps, calculated as gilts plus 80bps) which has been accessible to most authorities since 1st November 2012.

There has been a forecast decrease in the projected level of expenditure since the original estimate. This is mostly due to re-profiling of expenditure into 2024/25 (including £27m Towns Fund Regeneration schemes, £8m DFG, £7m transport and £17m HRA projects)

The borrowing need underlines the indebtedness of the Council by way of the Capital Financing Requirement (CFR), although this will be reduced in part by revenue charges for the repayment of debt known as the Minimum Revenue Provision (MRP). This direct borrowing need may also be supplemented by maturing debt and other treasury requirements.

5.2. Changes to the Prudential Indicators for the Capital Financing Requirement (CFR), External Debt and the Operational Boundary

The table shows the CFR, which is the underlying external need to incur borrowing for a capital purpose. It also shows the expected debt position over the period, which is termed as the Operational Boundary.

5.3. Limits to Borrowing Activity

The first key control over the treasury activity is a prudential indicator to ensure that over the medium term, net borrowing (borrowings less investments) will only be for a capital purpose. Gross external borrowing should not, except in the short term, exceed the total of the CFR in the preceding year plus the estimates of any additional CFR for 2023/24 and the next two financial years. This allows some flexibility for limited early borrowing for future years. The Council has approved a policy for borrowing in advance of need which will be adhered to if this proves prudent.

The Section 151 Officer can report that there are no difficulties envisaged for the current or future years in complying with this prudential indicator.

A further prudential indicator controls the overall level of borrowing. This is the Authorised Limit which represents the limit beyond which borrowing is prohibited and needs to be set and revised by Members. It reflects the level of borrowing which, while not desired, could be afforded in the short term but is not sustainable in the longer term. It is the expected maximum borrowing need with some headroom for unexpected movements. This is the statutory limit determined under section 3 (1) of the Local Government Act 2003.

Due to the current economic situation and high interest rate environment, any new borrowing need will be taken for short periods pending a drop in borrowing rates when the debt can be refinanced for longer periods at more advantageous levels, thereby preventing long term high debt costs on the revenue accounts of the Council.

6.1. Debt Rescheduling

Debt rescheduling opportunities have been very limited in the current economic climate and following the various increases in the margins added to gilt yields which have impacted PWLB new borrowing rates since October 2010, no debt rescheduling has therefore been undertaken to date, in the current financial year. However, now that the whole of the yield curve has shifted higher there may be better opportunities in the future, although only prudent and affordable debt rescheduling will be considered.

7. Investment Strategy 2023/24

Key Objectives

The approved Treasury Management Strategy Statement (TMSS) for 2023/24, includes the Council's Annual Investment Strategy. In accordance with the CIPFA Treasury Management Code of Practice, it sets out the Council's investment priorities as being:

- Security of capital
- Liquidity
- Yield

The Council will aim to achieve the optimum return (yield) on its investments commensurate with proper levels of security and liquidity and with the Council's risk appetite. In the current economic climate it is considered appropriate to keep investments short term to cover cash flow needs, but also to seek out value available in periods up to 12 months with high credit rated financial institutions, using the Link suggested creditworthiness approach, including a minimum sovereign credit rating and Credit Default Swap (CDS) overlay information.

Current Investment Position

The Council held £115.750m of investments as at 30 September 2023 (\pounds 125.487m as at 30 September 2022) with the structure of the portfolio being detailed below.

Risk Benchmarking

A regulatory development is the consideration and approval of security and liquidity benchmarks. Yield benchmarks are currently widely used to assess investment performance. Discrete security and liquidity benchmarks are new requirements to Member reporting, although the application of these is more subjective in nature.

Liquidity

In respect of this area, the Council set liquidity facilities / benchmarks to maintain:

- Bank overdraft £2m
- Liquid short-term deposits of at least £20m available within a week's notice.

The Section 151 Officer can report that liquidity arrangements have been adequate during the year to date.

Yield

Local measures of yield benchmarks are:

• Investments – Internal returns to be above the Overnight SONIA rate

The Section 151 Officer can report that the return to date has averaged 4.87%, against an average overnight SONIA rate at 30 September 2022 of 4.74%. The original Treasury Management Strategy Statement indicated that average yields for 2023/24 would be approximately 4.40%. The current interest rate environment remains higher than those original expectations and this has generated a higher return in investment income for the Council, which is reflected within the Q2 monitoring report.

8. Other

8.1 Compliant with Treasury and Prudential Limits

It is a statutory duty for the Council to determine and keep under review the affordable borrowing limits. During the half year ended 30 September 2023, the Council has operated within the treasury and prudential indicators set out in the Council's Treasury Management Strategy Statement for 2023/24. The Section 151 Officer reports that no difficulties are envisaged for the current or future years in complying with these indicators.

All treasury management operations have also been conducted in full compliance with the Council's Treasury Management Practices.

8.2 Changes in Risk Appetite

There is no change to the Council Risk appetite.

8.3 Creditworthiness Policy

The current approved creditworthiness policy and counterparty limits for investment balances remain fit for purpose and no changes are proposed.

- 2.3 The Council has decided to have three Independent Persons. The recruitment process has commenced to appoint two further Independent Persons, any recommendations as to a further appointment will be submitted to Council at a future meeting.
- 2.4 The appointment of Mr Richard Phillips is due to expire on 10 March 2024. Mr Phillips has indicated that he is happy to continue in the role and Council is therefore asked to consider an extension of Mr Phillip's appointment for a further four-year period. Any future extensions to existing Independent Person appointments will be delegated to the Monitoring Officer to approve.

The role of the Independent Person is advisory and is important in providing assurance to the Council and the public that standards matters are being dealt with effectively, fairly and proportionately.

The Committee on Standards in Public Life recommended that there should be at least two Independent Persons for Standards Matters. Their views must be sought and taken into account by the Council before it makes a decision on an allegation against an elected member that it has decided to investigate. The Independent Person's views may be sought by a member or co-opted member of the Council if that person's behaviour is the subject of an allegation, and may also be sought by the Council in relation to an allegation it has not yet decided to investigate.



4.2 In order to be eligible to be an Independent Persons Under S28 Localism Act 2011 the person must not be an Elected Member, Coopted Member or officer of Sandwell Council and they must not have been any of the above in the past five years prior to the Appointment.

2 Reasons for Recommendations

- 2.1 The proposal is on land allocated for housing within the Site Allocations and Delivery Development Plan Document. It is necessary for the Council to consider whether or not to grant an exception to its policy to allow the application to proceed.
- 2.2 Although the site is allocated for housing land, it is part of a wider allocation and could not be developed in isolation for residential development, as in close proximity to the site are located existing employment uses. For housing to be acceptable on the site, the Council would be looking for a comprehensive development of the wider residential allocation. The proposal is acceptable in its scale, design and appearance, would cause no harm to the safety and convenience of users of the highway and would not cause significant harm to the amenity of the occupiers of adjacent properties. Furthermore, the granting of a temporary approval would not prevent the site coming forward for residential development in the future which is the long-term aspiration.

4 Context and Key Issues

4.1 At the meeting of Planning Committee held on the 29 November 2023, consideration was given to planning application DC/23/67863 - Proposed change of use from general industrial to treatment, remediation and recovery facility for contaminated soils, construction, demolition and excavation of waste with 1 No. soil treatment shed and 4 No. office/meeting rooms, 1 No. mess drying room, toilet block, store, weighbridge unit, picking station, decontamination unit, clean material area and 2 No. holding tanks and covered post treatment areas, oversized processing area, parking and the creation of a new vehicular access - Temporary planning permission for 3 years.



- 4.2 At the meeting, the Committee approved the planning application with conditions subject to the application being referred to Full Council as a departure from the approved development plan.
- 4.3 The application was publicised by neighbour notification letter, site notice and press notice with 16 objections being received.
- 4.4 Council will need to approve the application as it is a departure from the Development Plan. The site is currently allocated for housing; therefore, it is necessary for the Council to consider whether or not to grant an exception to adopted policy to allow the application to proceed.
- 4.5 The purpose of this report is to discuss the 'departure' from the Development Plan only. It is not the role of Council to reconsider the wider planning merits of the application which have already been considered by the Planning Committee.
- 4.6 The Council's Highways, Planning Policy, Conservation Officer and Public Health (noise, contaminated land and air quality have all been consulted as well as West Midlands Police, Lead Local Flood Authority, Severn Trent, Health and Safety Executive and the Canal and River Trust. There were no objections subject to various conditions being imposed.

5 Alternative Options

5.1 Refusing the departure is an option, in doing so clear planning justification would have to be provided as any refusal of planning permission could result in an appeal and costs being awarded against the Council.

Motion Title: Support the introduction of Bus Franchising in the West Midlands

Proposer: Councillor Hackett Seconder: Councillor Millard

Council notes that bus passengers in Sandwell are rightly frustrated with many bus services operated by various providers across Sandwell, with many services proving to be unreliable.

Council further notes that trust in local transport is at an all-time low with passenger numbers and satisfaction falling and prices rising.

Council welcomes the opportunity bus franchising in the West Midlands presents, which could see the West Midlands Combined Authority given powers to decide routes, fares, frequency, hours and days of operation providing greater control over our bus services for communities right across Sandwell and the wider West Midlands.

Council therefore calls on the Combined Authority Mayor or any successor to commit to exploring all options for bringing in bus franchising across the whole West Midlands region to ensure our bus services are run in the interests of passengers and not solely based on profit.

Motion Title: Dependent Carers Allowance

Proposer: Councillor Smith Seconder: Councillor Hemingway

Council notes the increasing challenge seen locally and nationally at increasing and maintaining the diversity of elected members in local government. This requires a consistent approach to resolving the challenges different groups of people face. The payment of allowances to elected members who are parents and carers helps to bring a wider range of people into public office and supports them in remaining there.

Council further notes that data from The Fawcett Society report Does Local Government Work for Women? and the Local Government Information unit (LGiU) makes clear that women councillors experience more barriers to holding office. These barriers include unpaid caring responsibilities, the timing of meetings and a lack of flexibility in how councils do business. Women councillors experience these barriers much more than their male counterparts. This has created an imbalance in local government throughout the country.

Council is justly proud of our record in supporting diversity and inclusion and encouraging people from all backgrounds to aspire to and assume public office and positions of leadership.

Council notes the recent report and recommendations from the Independent Remuneration Panel that Sandwell Council extend our existing member allowances scheme to include wider dependent carer responsibilities as well as removing the requirement to use the Council House Workplace Nursery.

Council therefore resolves to call on the Governance and Constitution Review Committee to bring forward proposals to amend and update our Dependent Carers Allowance Scheme, taking note of the recommendations from the Independent Remuneration Panel and in line with the recommendation from the Fawcett Society as well as best practice from existing schemes around the country.

Motion Title: Re-instating of a Justice Centre in Sandwell

Proposer: Councillor Webb Seconder: Councillor Tipper

Council considers the justice system a fundamental pillar of democracy that works to protect and advance the principles of justice, and should work for everyone in Sandwell as well as for the wider Black Country.

Council notes the 2016 decision of Government to close the Justice Centre in Sandwell. Sandwell residents are disproportionally affected by this, not having direct public transport to each of the other Black Country authority's remaining justice centres. Other more direct forms of transport are made difficult through financial and social circumstances.

Council notes with concern that there are record number of cases being delayed in the West Midlands in the Criminal Courts but there are also cases are mounting up in the Family Courts. Wolverhampton Crown Court has 900 cases waiting to be heard including cases of murder and manslaughter.

Council further notes with concern that a range of other cases such as work-related death and causing death and injury through dangerous driving are not being scheduled to be heard until 2025. This means meaning that some families could have had to wait 8 years for their cases to be heard. This is too long, and families should have access to justice in a timely manner.

Council therefore calls on the Leader and Chief Executive to write to the Lord Chancellor and Secretary of State for Justice setting out the terms of this Motion and calling on the Secretary of State to take steps to reopen a justice centre within Sandwell at the earliest opportunity.

Motion Title: A borough of Six Equal Towns!

Proposer: Councillor Gill Seconder: Councillor Fisher

Council recognises that Sandwell is made up of 6 towns and whilst each town is unique and distinct, we share far more that unites us than divides and are stronger together. In turn, residents across the Borough need to be assured that all towns of our Borough are always treated equally.

Council notes that the towns of West Bromwich and Smethwick have received far more investment than all other towns in our Borough. Tipton, in particular, has received particularly less investment funding compared to the other towns as evidenced on the Council's regenerating Sandwell website.

Council recognises that all of our High Streets and Town Centres require balanced funding and attention to prosper.

Council therefore calls on the Leader and Cabinet to level up our towns and support our high streets and town centres by considering introducing a policy that ensures all Council-owned car-parks near town centres, or High Streets like Great Bridge, have free parking for a period of 3 hours to support small businesses and make it even easier for people to shop in Sandwell.
