# 6/23 Nominations for Honorary Alderman/Alderwomen

The Local Government Act 1972 gave authority to the Council to confer the honour of Honorary Aldermen/ Alderwomen of the Borough on Elected Members who had given eminent service to the Borough. This honour was in accordance with the Council's honorary scheme.

A nomination for the conferment of the title of Honorary Alderman had been received from Councillor Gavan in respect of former Councillor Mohinder Singh Tagger.

Former Councillor Mohinder Singh Tagger served on Sandwell Metropolitan Borough Council for 26 years, he had served as the Deputy Mayor for the Municipal Year 2006-2007, had held the position of Vice- Chair for Licensing Committee and Scrutiny Boards for a number of years.

The Committee considered his additional contributions to the Borough of Sandwell through his various charitable, community and voluntary activities and concluded that he fulfilled the eminent service criteria associated with the honour. Mohinder Singh Tagger had confirmed that, if the Council was so minded, he would accept the nomination for the honour.

**Resolved** that Council be recommended to confer the title of Honorary Alderman to Mohinder Singh Tagger in recognition of his eminent service to the Borough of Sandwell.

# 8/23 Leonard Andrews Poole Trust Annual Report 2022/23

The Committee was informed that the Leonard Andrews Poole Trust was established in 1980 and had been registered with the Charities Commission.

The Trust held shares on deposit with COIF Charities Investment Fund managed by the CCLA valued at £145,031.40. Interest which had accumulated from the investment could be utilised for the benefit of Grafton Lodge Care Home or any care home managed by Sandwell Council.

No financial expenditure had been incurred during municipal year 2022/23, the Trust had an average annual income of  $\pounds4,200$  via interest per annum.

Funds had been available to Harvest View and Fountain Court residences upon the submission of a report, subject to approval by the Committee.

The Committee considered and noted the Leonard Andrews Poole Trust financial position.

# 10/23 Appeal against the Decision of the Adaptations Panel

The Committee considered an appeal against the decision of the Adaptions Panel in respect of Ms N R.

The Committee was advised that Ms N R had sought to appeal the decision of the Adaptation Panel to adapt the property, to include a ground floor access shower, .

Ms N R stated that the approved adaptation did not adequately meet the needs of her son due to his disabilities and sought approval to an alternative adaptation, which would exceed the cost of £25,000, but would provide dignity and privacy for her son and his complex disabilities.

Having considered all the information before them, the Committee was minded to uphold the appeal on the grounds of dignity and privacy and felt that the appellants proposed adaptation better suited her son's needs for the future as well as making better use of space.

**Resolved** that the appeal is upheld and that the Appellant's proposed scheme of adaptations is approved.



# 4 Context and Key Issues

- 4.1 In order to recognise eminent or notable service rendered to the Borough by former Councillors, in 1997, the Council introduced a scheme for the enrolment of Honorary Alderman of the Borough. This scheme was amended in 2008 to reduce the required number of years' service to twelve and in 2013 to reflect Section 29 of the Local Democracy, Economic Development and Construction Act 2009 to the effect that any reference to Honorary Alderman should be followed by the insertion of Honorary Alderman/Alderwomen.
- 4.2 The Local Government Act 1972 gave authority to the Council to confer the honour to elected members who had given eminent service to the Borough. Local Authorities define the operation of the scheme within their Council areas.
- 4.3 The Committee is requested to consider a nomination by Councillor Peter Hughes, to award an honorary title upon Mrs. Elaine Costigan.
- 4.4 Former Councillor Elaine Costigan served on Sandwell Metropolitan Borough Council for 20 years, she had served on a number of Committees over the years, most notably served as Cabinet Member for Health & Protection, and as Town Lead for Wednesbury.
- 4.5 In accordance with the scheme of enrolment, Elaine Costigan has indicated her willingness to accept the nomination for enrolment as Honorary Alderwomen.
- 4.6 If the Committee is minded to support the nomination, the Committee's recommendation will be submitted for consideration at an Extraordinary Council meeting, immediately prior to the ordinary meeting of Full Council, scheduled to be held on the same day.

# 4 Context and Key Issues

- 4.1 The Leonard Andrews Poole Trust is a Trust fund set up in 1980 from a bequest by Leonard Andrews and is registered with the Charities Commission.
- 4.2 The bequest stipulated that the funds could not be spent and must be held in perpetuity; however, any interest arising from the investment can be utilised for the benefit of residence of Grafton Lodge care home or any care home managed by Sandwell MBC.
- 4.3 The Trust holds 7,767.32 shares on deposit with COIF Charities Investment Fund managed by CCLA. COIF is a long-term, sustainable investment solution which incorporates environmental, social and governance (ESG) considerations into the investment strategy. COIF is considered suitable for charities looking for a good level of distributions



and protection from inflation. The portfolio has a bias towards real assets, predominantly global equities but also property investments and infrastructure.

# 4.4 Trust Financial Position

- 4.5 The closing bank balance is available for the benefit of residents of council managed residential style unit of which there are currently two Harvest View and Fountain Court. No expenditure was incurred during 2022/23. Average annual income levels are £4,200 per annum and the annual income yield is forecast to be 2.91% for 2023/24.
- 4.6 The Trust holds 7767.32 shares which had an opening valuation on £153,327.67 as at 1 April 2022 the current value of the shares is £145,533.17 a decrease of £7,794.50 during the financial year. Share prices can go up and down however; the rate of dividends remains consistent.
- 4.7 The managers at Harvest View and Fountain Court have been made aware of the level of funds available and their potential uses and have submitted a separate report to request approval to spend.
- 4.8 Members of the General Purposes Committee are the Trustees of the Leonard Andrews Poole Trust and as such we are required to update the Charities Commission with Trustee's details. The following information is required from all Trustees:

#### **1** Recommendations

- 1.1 That the Board considers and comments upon a request for funds from the Leonard Andrews Poole Trust to provide garden furniture for the residents at Harvest View Health & Social Care Centre.
- 1.2 That the Board agrees for a procurement exercise to be undertaken to source suitable garden furniture to meet the needs of the residents at Harvest View Health & Social Care Centre.

# 2 Reasons for Recommendations

Harvest View opened to residents in November 2022 and is Sandwell's new flagship social care and health facility. Harvest View in Rowley Regis offers specialist support from both social care and health staff all under one roof, with 80 en-suite rooms and friendly communal areas as well as lovely outdoor spaces. The facility enables people to get back home after a hospital visit and also those who need some structured support to avoid a hospital stay altogether. Harvest View replicates the home environment, where residents can be encouraged back to their normal health in familiar surroundings. The focus is on maintaining and



improving independent living rather than specifically treating the medical condition.

The outdoor areas consist of lawned areas, flat winding pathways to encourage mobility, and raised beds for gardening and growing vegetables. There is a large area that was designed as a communal space to encourage interaction between residents, with a view that this would house tables and chairs for a relaxed outdoor space for residents to enjoy. This could be a place for rest, relaxation, communication, visits from family/friends or an outdoor dining space. Please see Appendix 1 for an image of this area.

Unfortunately, there were not sufficient funds nor contracts available at the time of the build of Harvest View to source tables and chairs for this outdoor area. The requirement aligns with the priorities for the Leonard Andrews Poole Trust funding and will have a great impact on the quality of service provided at Harvest View.

# 3 How does this deliver objectives of the Corporate Plan?

	People live well and age well Upon arrival at Harvest View each resident is assessed and a bespoke reablement plan and goals is agreed with them. This is delivery by a multi-disciplinary team of professionals. Goals often include an improvement in physical function or mobility. There are large corridors for mobility practice, however the winding pathways in the outdoor area further encourage and replicate the person's own environment at home or in the community. The additional of tables and chairs in this area will support the delivery of the reablement programme, providing a suitable space to rest, reflect and undergo further assessment from the Occupational Therapist or Physiotherapist. The overall aim to maximise a person's reablement potential, enhance their wellbeing and enable
	them to return home.

park. It was designed to encourage the facility to feel part of the community in Rowley Regis, encouraging interaction with the local area and residents. Many of the staff working at Harvest View live in the local vicinity.

An outdoor seating and eating area would prolong the period of time residents may spend outside, increasing the interaction with the local community.

# 4 Context and Key Issues

4.1 Consultation has been completed with Occupational Therapy colleagues, to confirm the height, type and style of seating and tables that are likely to meet the needs of the majority of residents.

In order to establish an approximate cost and number of items required a quote has been obtained from company for; 5 x square dining tables, 20 x armchairs.

The requested funds to undertake a procurement exercise is £5,000.

# 5 Implications

Resources:	Investment requested from Leonard Andrews Poole Trust funds to purchase the items; quotes indicate this to be around £5,000. The Leonard Andrews Poole Trust currently has £31,542 available. The annual income is approximately £4,800.	
	Harvest View will then take responsibility for ongoing maintenance and possible replacement over time.

Risk:	The tables requested are of a heavy weight to reduce the likelihood of them being moved or removed from Harvest View. The chairs are of a more lightweight construction to suit the needs of our more vulnerable and frail residents. These will be of a powder coated aluminium construction to allow for suitable cleaning to adhere to infection control measures.	



Equality:	Consultation has been completed with Occupational Therapy colleagues, to confirm the height, type and style of seating and tables that are likely to meet the needs of the majority of residents. Due to the short term nature of residents at Harvest View (up to 6 weeks) and bespoke needs for outdoor seating will need to be considered on a case by case basis.
Health and Wellbeing:	The set reablement goals are designed to maximise a person's reablement potential, enhance their wellbeing and enable them to return home. The availability of an outdoor seating and dining area, provide further opportunity for the reablement programme.
Social Value:	Procurement exercise to be undertaken, as per the procurement rules this will look to ensure a Sandwell or West Midlands Combined Authority companies are able to quote for this requirement.
Climate Change:	Items sourced will be of a suitable construction for outdoor use using materials that will last throughout the seasons and can be cleaned and restored if needed.
