The Members' Allowances Scheme was approved for the period ending 31 March 2020 by the Council on 22 May 2018 and 21 May 2019.

Basic allowance is intended to recognise the time commitment of all members, including such inevitable calls on their times as meetings with officers and constituents and attendance at standing bodies of the Council. It is also intended to cover the cost of travel and subsistence within the West Midlands Conurbation area (i.e. within the boundaries of Birmingham, Coventry, Dudley, Sandwell, Solihull, Walsall and Wolverhampton). The basic allowance is also intended to cover fixed telephone rental and calls and other incidental costs such as the use of their homes.

Special responsibility allowances are paid to Members who carry out additional duties ranging from Leadership, Board, Committee and Town Chairs and Vice Chairs and Civic duties. Members with multiple roles can only receive 1 special responsibility allowance.

All members are entitled to claim an allowance to cover broadband provision for internet connection. Only one claim per household is paid.

To support the Council's paper light agenda each member receives a monthly allowance to offset the cost to them of procuring, insuring and using tablet technology.

In addition, three Councillors were reimbursed with a collective total of £99.50 (shown in the final column above) relating to travel expenses for official duties undertaken outside of the West Midlands Conurbation. No subsistence claims were made.
