The Borough Council of Sandwell (Waiting Restrictions, Brandhall and Warley) (Traffic Regulation Order No.21)

Action Taken Under Delegated Powers

1. <u>Summary Statement</u>

1.1 Approval is sought to introduce changes to Waiting restrictions in parts of the Borough to control parking where problems have been brought to the Councils attention.

The proposed restrictions are;

- Apsley Road, Oldbury. Introduce No Waiting At Any Time between 86 and 88 to prevent obstructive parking to access to Allotments.
 - Bertram Road, Smethwick. Introduce a length of Limited Waiting Monday to Saturday 8am to 6pm fronting City Computer Systems to provide a turnover in parking to assist businesses.
 - Birchfield Lane, Oldbury Introduce No Waiting At Any Time fronting Shotglass Technology, 80 82 to prevent obstructive parking.
 - Brennand Road, Oldbury. Introduce No Waiting at Any Time at its junctions with Aldridge Road and Edinburgh Road to prevent obstructive parking and improve road safety.
 - Clent Road, Oldbury. Add existing school entrance marking No Stopping Monday to Friday 8am to 4pm to order.
 - Devonshire Road, Smethwick. Introduce No Waiting At Any Time at junction with Walter Road and St Albans Road to protect the junction and improve road safety.

- Farm Road, Oldbury. Introduce No Waiting At Any Time adjacent to No140 to protect public access to Allotment Gardens.
- Grafton Road, Oldbury. Introduce No Waiting At Any Time at its junction with Ferndale Road to prevent obstructive parking and improve road safety.
- Hadley Street, Oldbury. Introduce No Waiting At Any Time to cover rear access adjacent to No2 in a North-westerly direction to cover access to No22 Causeway Green Road to prevent obstructive parking and improve road safety.
- Pavilion Avenue, Smethwick Introduce No Waiting at Any Time on the inside of the bend from 5 pavilion Avenue to 166 Broadmoor Avenue to prevent obstructive parking and improve road safety.
- Sabell Road, Smethwick. Extend existing No Waiting At Any Time restrictions both sides from its junction with St Pauls Road to prevent obstructive parking and improve road safety.
- Salop Road Cul-De-Sac, Oldbury. Introduce No Waiting At Any Time both sides and at junction with main to prevent obstructive parking and improve road safety.
- Vicarage Road, Oldbury. Extend existing No Waiting At Any Time between entrances to Peartree House to prevent parking.
- Vicarage Road, Oldbury (Parking Area) Introduce No Waiting At Any Time at entrance to communal parking area adjacent to No101, to prevent obstructive parking and improve road safety.
- West End Avenue, Smethwick. Cover existing No Waiting At Any Time with No Loading Monday to Friday 8am to 4pm to prevent parents blocking School Entrance.
- Western Road, Oldbury. Introduce No Waiting at any time at the junction with Station Road to Protect access to Express Bonding to prevent obstructive parking and improve road safety.

As shown on drawing set number 40,320 S/4.

- 1.3 The introduction of the above measures are subject to consultation in conjunction with the advertising of the Traffic Regulation Order. Any unresolved objections would need to be reported back to the Cabinet Member for Sustainable Transport for a decision.
- **1.4** The cost to make the Traffic Regulation Order including advertising, signs and lining would be in the region of £6,500. This will be funded from the Parking Account.

2. Recommendation

- 2.1 That the proposed restrictions in the Borough Council of Sandwell (Waiting Restrictions, Brandhall and Warley) (Traffic Regulation Order No.21) be made as detailed in 1.2 and shown on drawing set No. 40,320 S/4.
- 2.2 That the proposed restrictions in the Borough Council of Sandwell (Waiting Restrictions, Brandhall and Warley) (Traffic Regulation Order No.21) are advertised for the statutory consultation.
- 2.3 That the Director Regeneration and Growth submits a report to the Cabinet Member for Sustainable Transport on unresolved matters.
- 2.4 That the Director Monitoring Officer be authorised to seal the Borough Council of Sandwell (Waiting Restrictions, Brandhall and Warley) (Traffic Regulation Order No.21)

In accordance with the authority delegated to Directors to act on matters within the authority delegated to them under Part 3 of the Council's Constitution, I intend to take the action(s) recommended above.
