Tender for: Supply and fit of two and four pole isolator Switches

1. Summary Statement

- 1.1 The council is seeking to appoint one Contractor to supply and fit two and four pole isolator switches to Void and Tenanted properties within Sandwell MBC.
- 1.2 The value of the contract is £44,400 (£11,100 per Annum) for a period of 4 years, from 1st February 2019 to 31st January 2023.
- 1.3 The current contract expires on 31st January 2019.
- 1.4 In order to comply with the council's Procurement and Contract Procedure Rules, a quotation exercise was held inviting bids from suitable companies. The award criteria is based on 100% price.
- 1.5 Eleven expressions of interest were received, only two companies returned a compliant quotation by the deadline 20th September 2018.
- 1.6 The quotations were evaluated in accordance with the stated award criteria and the contractor with the winning submission is; Haste Ltd.

2. Recommendation

2.1 Following evaluation of the returned quotations it is recommended that the Director of Housing and Communities awards the contract for the supply and fit of two and four pole isolator switches to Void and tenanted properties to Haste Ltd, in the sum of £44,400 (£11,100 per Annum) for a period of 4 years, from 1st February 2019 to 31st January 2023.

3.1 The proposed £44,400 contract for the supply and fit of two and four pole isolator switches to Void and tenanted properties is included within approved Housing Revenue Account budgets.

4.1 The Council, as a Public body, has to comply with Public Contracts Regulations (2015). This tender exercise has been conducted using an open procedure.

6. Background Details

- 6.1 This contract is required to enable the Asset Management and Maintenance Repair and Void teams to safely undertake repair work on the electrical fuse boards in SMBC properties. The contractor installs a isolator switch between the electrical meter and the fuse board so that the power supply can be isolated safely.
- 6.2 The value of the contract is £44,400 (£11,100 per Annum) for a period of 4 years, from 1st February 2019 to 31st January 2023.
- 6.3 The Current contract expires on 31st January 2019.
- 6.4 In order to comply with the council's Procurement and Contract Procedure Rules, a quotation exercise was held inviting bids from suitable companies.
- 6.5 The quotations were returned by the deadline 20th September 2018.
- 6.6 All quotations were analysed in accordance with the award criteria based on 100% price.
- 6.7 The most competitive quotation received is from Haste Ltd.
