Action Taken Under Delegated Powers

12th January 2018

1. Summary Statement

- 1.1** Approval is sought to amend The Borough Council of Sandwell (The A457 Tipton to Oldbury) (Red Route) Order 2013, Traffic Regulation Order.
- 1.2** A Red Route Traffic Regulation Order is in place for A457 Park Lane West, Tipton. This includes No Stopping At Any Time restrictions along parts of the road. A new residential property is to be constructed and part of the planning condition requires an on-street parking space to be provided.
- 1.3** The changes to the No Stopping restrictions are subject to consultation in conjunction with the advertising of the Traffic Regulation Order. Any unresolved objections would need to be reported back to the Cabinet Member for Highways and Environment for a decision.
- 1.4** The cost to amend the Traffic Regulation Order including advertising, new signs and lining would be in the region of £4000 and has been funded by the developer.

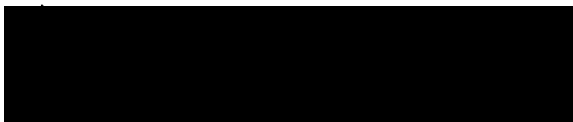

- 2.3 That the Executive Director Neighbourhoods submits a report to the Cabinet Member for Highways and Environment on unresolved matters.
- 2.4 That the Director - Governance be authorised to seal the Borough Council of Sandwell (The A457 Tipton to Oldbury) (Red Route) Order 2018 Revision of Parking.

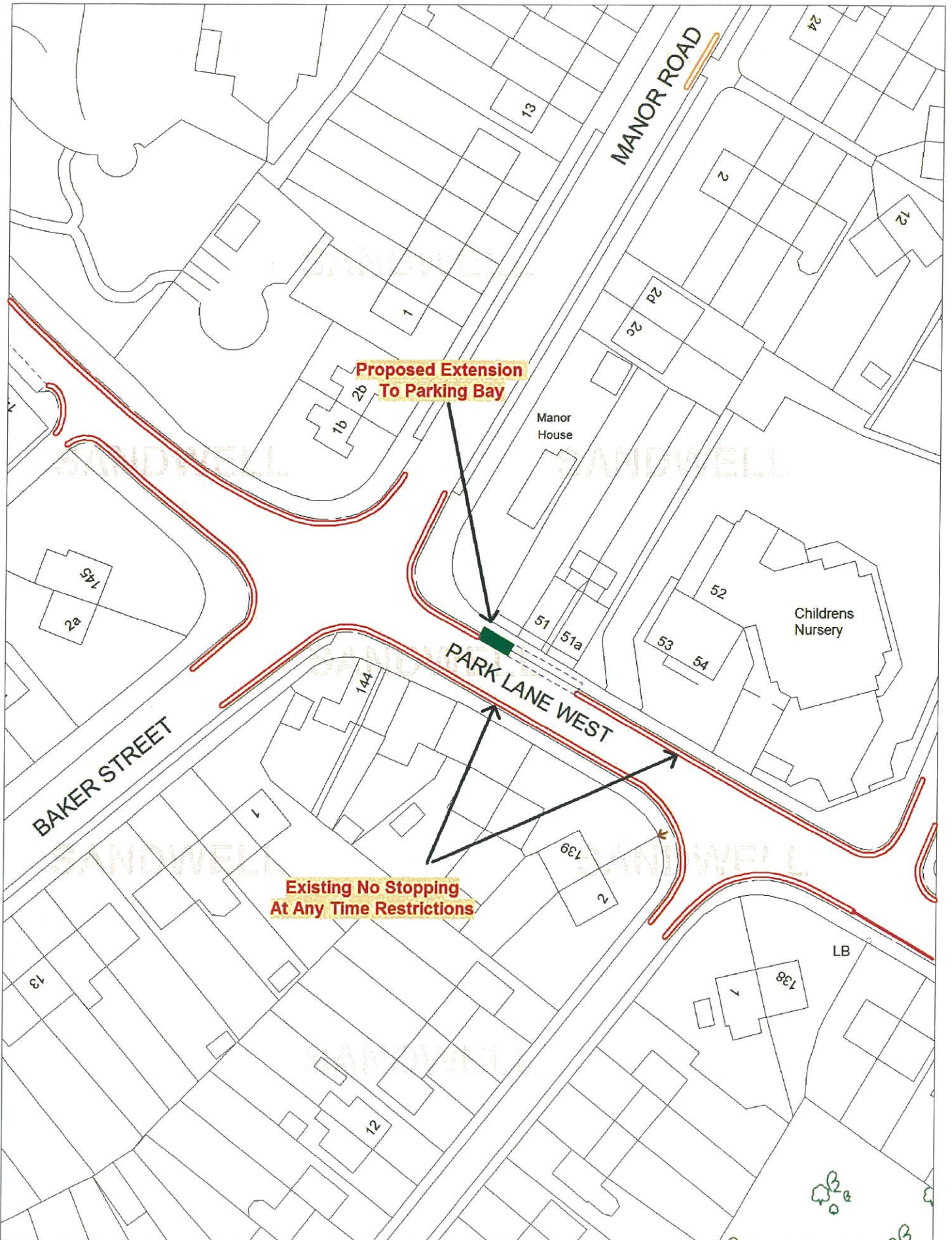
