Resolved that the minutes of the meeting held on 5th June 2015, be confirmed as a correct record.

7/15 The Gambling Act 2005 – Review of Statement of Principles

Section 349 of the Gambling Act 2005 required the Council, as Licensing Authority, to prepare and publish its own Statement of Principles as to how it intended to carry out its licensing functions under the Act.

The Council's current Statement of Principles was approved by full Council on 4th December, 2012 (Minute No. 123/12 refers).

The Act required the Council, in respect of each three year period, to determine its principles with respect to the exercise of its licensing functions and to publish a statement of those principles on the Council's website before the beginning of the period. The current three year period required the Authority to prepare and publish a policy statement by 3rd January 2016, with it coming into force on 31st January 2016.

Licensing Committee – 10th July, 2015

Before determining its principles, the Act specifically required the Licensing Authority to consult the following:-

- the chief officer of police;
- persons representing the interests of those carrying on gambling businesses within Sandwell;
- persons representing the interests of anyone likely to be affected by the exercise of the Council's functions under the Act.

The draft revised Statement of Licensing Policy (Gambling) contained the information that the Gambling Act 2005 (Licensing Authority Policy Statement) (England and Wales) Regulations 2006 had prescribed should be included within the policy document.

Consultation would be undertaken during July and August 2015 involving statutory bodies, trade organisations, representatives of licence holders and representatives of those likely to be affected, including all ward councillors and Members of Parliament.

Should there be any issues arising from the consultation, a further report would be submitted to Licensing Committee on 4th September, 2015.

The Statement of Principles would be submitted to full Council, at its meeting on 20th October 2015, for approval.

Under the provisions of Section 166 of the Gambling Act 2005, licensing authorities were able to pass a resolution stating that it would not be issuing any new casino premises licences. A resolution not to issue casino premises licences would only affect new casinos and would not affect the ability of existing casinos from continuing to operate as a casino. The Act also stated that any such resolution would lapse within three years, however, the authority would have the ability to pass a new resolution. In December 2012, the Council resolved that new casino premises licences would not be issued.

The Committee recommended that full Council renew the resolution not to issue casino premises licences to new casinos when consideration was given to the revised Statement of Principles.

Resolved:-

- that, in accordance with the Gambling Act 2005, and subject to any comments received as a result of the consultation process, Council be recommended to approve the revised Statement of Principles, with effect from 31st January 2016;
- that, in connection with (1) above, the Council be recommended to renew the resolution not to issue casino premises licences to new casinos for a further three year period;
- that the Director Homes and Communities submits a further report in relation to any issues arising as a result of the consultation process;

Review of Fees and Charges under the Gambling Act 2005

1. Summary Statement

- 1.1 Background:-
 - This report sets out the proposed fees and charges for the period 2016/17 in relation to premises licences and other permissions under the Gambling Act 2005;
 - Fees are determined by statute with local determination up to a prescribed maximum level.
- 1.2 Financial Impact on the Council:-
 - A 3% uplift on the Gambling fees and charges;
 - The total projected income from the fees and charges described in this report is anticipated to be around £28,000;
 - The division has considered the following factors when developing its proposed fees and charges:-
 - the Council's Medium-Term Financial Strategy;
 - the volatility of the economic environment in which local businesses and traders operate;
 - It is anticipated that service levels will not vary considerably by the levying of the increased fees and charges;
 - The costs of all 'charged for' services are covered by the income received.

1.3 Impact on Service Delivery

- The proposed change in the levels of fees and charges is intended to cover the reasonable costs of providing those services and to meet the budget assumptions contained in the Council's Medium-Term Financial Strategy;
- It is not anticipated that levels of demand will vary greatly as a result of increasing the fees and charges as outlined in this report.
- 1.4 Rationale & Assumptions:-
 - Fees determined by statute remain unaltered from 2012/13;
 - All other fees and charges have been raised by 3% (rounded in some cases) in line with the Council's Medium-Term Financial Strategy;
 - Levels of licensing activity remain vulnerable to market conditions. However, the quasi-judicial and legal infrastructure has to be maintained, together with the Council's inspection and enforcement responsibilities.
- 1.5 Consultation:-
 - The Council's policies under both the Licensing Act 2003 and Gambling Act 2005 are subject to regular review and consultation with the widest possible range of stakeholders. The list of stakeholders is subject to agreement with the Licensing Committee.
 - The Councils Gambling Policy 2005 'Statement of Principles' was approved by Full Council on the 20th October 2015 and will be implemented on the 31st January 2016. Consultation was undertaken as a part of the review.
- 1.6 Benchmarking:-

Benchmarking with other local authorities and private organisations has indicated that where relevant fees or charges apply, that charges are still comparative with neighbouring authorities. Benchmarking comparable Council charges within the West Midlands has been undertaken. The information is available on request and can be summarised as follows:-

- The Gambling Act 2005 requires local authorities when setting fees that the Council must aim to ensure that the income raised equates as nearly as possible to the cost of providing the service to which the fee relates.
- 1.7 At its meeting on 13 January 2016, the Cabinet recommended that the Licensing Committee approve the fees and charges set out in Appendix 1 to this report, with effect from 1 April 2016.

2. Recommendation

2.1 That the Licensing Committee approves the fees and charges for 2016/17 set out in the Appendix to this report, for premises licences and permissions under the Gambling Act 2005 with effect from 1 April 2016.

3. Strategic Resource Implications

3.1 In setting the budget proposals for 2016/17, the anticipated levels of income from the fees and charges detailed in this report have been taken into account.

4. Legal and Statutory Implications

- 4.1 Section 2 of the Gambling Act 2005 provides that the Council is a Licensing Authority. The 2005 Act places a duty on Local Authorities to undertake the licensing functions specified in the Act. The setting of fees is provided by Section 212 of the 2005 Act. Section 212 (1) of the Act states regulations proscribing a fee may provide for the amount of the fee to be determined by a Licensing Authority, and may, if they make provision, specify constraints on a Licensing Authority's power to determine the amount of the fee.
- 4.2 In establishing the fees and charges outlined within this report for 2016/17consideration has been given to the 'Hemmings principles' for all discretionary fees.

5. Implications for the Council's Scorecard Priorities

5.1 The fees charged under the Gambling Act 2005 are in respect of services delivered with the objective of securing compliance with legal requirements in order to promote a safe and clean place to live.

6. Background Details

6.1 The Council requires all Divisions to undertake a review of its fees and charges on an annual basis.
