

## **Scrutiny Review - Scoping Document**

Review Title:	Strategic Road Safety Plan
Scrutiny Board:	Economy, Skills, Transport and Environment
Date of Review:	2022

## Reasons for undertaking the review:

On 18 January 2022 the Council asked the Economy, Skills, Transport and Environment Scrutiny Board to conduct a review into the current Strategic Road Safety Plan. The current Strategic Road Safety Plan covers the period 2017-2022 and is therefore due to be re-written in 2022.

Taking into account global, national regional and local strategy and policy and the statutory requirements of the Road Traffic Act 1988 (Section 39), as well as the Council's statutory obligations, the review will consider the growing challenges that Sandwell faces, including an increasing number of vehicles on the road, climate change, adaptations to public transport and other such imperatives and will make recommendations how these challenges can be addressed in the revised Strategic Road Safety Plan and accompanying Action Plan.

## **Intended Outcomes:**

- Understand how the Plan takes account of the statutory requirements of the Road Traffic Act 1988 (Section 39) and global, national regional and local policy.
- Determine whether they key priority groups in the current Plan are still appropriate.
- Determine whether the key performance indictors in the current Plan are appropriate.
- Understand how funding is allocated regionally and locally.
- Understand the criteria/prioritisation methods for the various methods of traffic calming measures and their effectiveness.
- Understand the criteria for determining targeted campaigns.
- Review data on road causality analysis to support the implementation of 20mph zones.
- Understand enforcement practices (WMP) and the impact of.
- Understand the Fatal Collison Protocol with WMP and the impact of this.
